## New homeless shelter proposed for Midway

The Midway District is one of three areas recently designated by Mayor Kevin Faulconer for use as a new temporary “bridge-to-housing” shelter, as part of a new public-private partnership to help homeless get off the street.

The proposed Midway

shelter will be administered by Veterans Village of San Diego, a nationally recognized nonprofit that has served veterans since 1981 providing a continuum of care with a full range of comprehensive services. The new homeless center is to be located on

a lot in the 2700 block of Sports Arena Boulevard (behind the Goodwill store).

"San Diegans are compassionate people who want to help solve this crisis," Faulconer said in announcing the homeless transitional program.

"Their government must channel that compassion into action, offering more clean and safe spaces that transition the homeless from living on the streets, to living in a permanent home. That is exactly what San Diego needs right now."

"This represents a significant

expansion of our homeless service network, and is one of the most immediate and effective actions we can take to provide relief to unsheltered people who are suffering and want help," he said.

Faulconer added bridge shelters are "An innovative approach that reflect best practices in serving the

most vulnerable members of the homeless population. They serve as a crucial transition point where housing navigators will work with men and women without shelter to find them a permanent housing placement."

The new homeless transitional facility will consist of a large, industrial tent with more than 100 beds with restrooms, showers, meals and 24-hour security. The service providers will offer supportive services and connections to health care, alcohol and substance abuse counseling and job search training at all three locations.

Reacting to the news of the new transitional homeless center in its midst, Kimberly Mitchell, president

and CEO of Veterans Village, said, "Veterans Village is proud to partner with the City of San Diego to address the critical issue of homelessness in our community."

"Particularly troubling are the veterans who have served our country over the course of the last 50 years, but now find themselves struggling with homelessness on our streets. We appreciate Mayor Faulconer's leadership on this issue and the City of San Diego's partnership with Veterans Village to be part of the solution," she said.

Mitchell said Veterans Village is happy to run a new transitional homeless tent.

## City to sanitize sidewalks in beach communities

With a program in place to regularly sanitize the sidewalks in the most critical areas of downtown, the City of San Diego is now expanding those efforts to other neighborhoods based on need to combat the hepatitis A outbreak.

Cleaning began this week in parts of the Midway area, Ocean Beach and Pacific Beach, and crews will work in Uptown and Mid-City on Friday. Sidewalk sanitizing is one of the key actions the city is taking to assist the County of San Diego's efforts to eradicate the virus.

On Sept. 11, the city began power washing sidewalks with a bleach solution in different areas downtown three times weekly, following the guidelines set by the County Public Health Officer to effectively kill the hepatitis A virus.

To report public areas in need of power washing, residents can contact their City Council representative, call the city's dispatch center at 619-527-7500 or make an online request at [sandiego.gov](http://sandiego.gov). The city has opened three new secure 24-hour restroom facilities, each with four separate stalls.

## Suspect in 2011 murder extradited from Mexico

A man charged with fatally shooting Jalal (Joe) Abou in his Point Loma auto shop in 2011, appeared Friday in court and waived his right to have a speedy hearing.

Nicolas Rosales, now 53, has pleaded not guilty to murder after being extradited from Mexico on Sept. 12.

Abou, 63, was shot to death at his shop at Joe's Auto Repair on Rosecrans Street on April 19, 2011.

He was found about 7:30 a.m. and was pronounced dead. Rosales

used to work for him.

Rosales fled the area to Mexico and was arrested for an unspecified crime, for which he was sent to prison. Mexican officials located him in the prison after his term ended, and the U.S. Marshal's Service arrested him Sept. 12 in Mexico City.

Rosales appeared Friday before San Diego Superior Court Judge Lisa Rodriguez, who set a preliminary hearing for Jan. 24, 2018.

Rosales was arraigned last week, and agreed with his attorney Friday to delay the preliminary hearing, which had been set for Sept. 28.

He remains in the central jail on \$4 million bail.

## \$1,000 reward offered for suspect wanted in Ocean Beach homicide

San Diego County Crime Stoppers and investigators from the San Diego Police Department's Homicide Unit are asking for the public's help in identifying and locating an unknown suspect wanted for the murder of Walter (Incense Man) Riley in the Ocean Beach area.



On June 22, at 12:28 a.m., 65-year-old Walter (Ras) Riley was stabbed multiple times in the area of 1900 Bacon Street, in Ocean Beach. Riley was transported to a local hospital, but later died as a result of his injuries. The suspect was last seen running eastbound in the north alley of 4900 Newport Avenue.

Suspect's description: The suspect (above) is described as a white or Hispanic male, wearing a gray hooded sweatshirt and dark colored pants.

## City to pay \$12.5M to family whose child was killed in Point Loma

The San Diego City Council on Sept. 19 unanimously approved a \$12.5 million payment to settle a lawsuit brought by a family that contends dangerous driving conditions led to a roadway accident that killed a baby and injured her father.

The litigation stemmed from a March 2, 2015, crash at Catalina Boulevard and Cañon Street. Police said David Allen Hoban told them his view was obstructed by foliage as he entered the intersection and struck a man who was pushing his 7-month-old daughter in a stroller around 6:30 a.m.

Juniper Aavang was fatally injured and her father, John Aavang, suffered serious head injuries. Police said the Aavang family was visiting from Illinois.

The family's attorney, Robert Hamparyan, said the city was aware of the obstruction after having received complaints from residents in the area.

Defendants also included property owners John and Helia Reis and the Point Loma Woods Property Owners' Association.

The parties reached a tentative settlement in April in which the Aavangs will receive a total of \$18 million from all defendants combined. The City Council gave initial blessing to its portion of the agreement in closed session in May.

The council passed the item without comment.

## Hurricane dogs are available for adoption

Of the dogs and puppies flown in from a Louisiana shelter, more than 30 are available for adoption at San Diego Humane Society's San Diego Campus, 5500 Gaines St.

A Wings of Rescue flight transferred these pets to San Diego Humane Society, Rancho Coastal Humane Society and Labradors and Friends from Acadiana Animal Aid to create space for pets who were being evacuated from Texas and Louisiana when Hurricane Harvey made landfall last week.

These pets are not direct victims of Hurricane Harvey. They are highly adoptable dogs who were in animal shelters in the Lafayette area. They do not have owners who will be searching for them.

We left off after Steve Yeng's parents escaped the Khmer Rouge regime and its "Killing Fields." They ran a successful butcher business, but left everything in Cambodia to find help in Thailand for 1-year old Steve, suffering from Polio. ## Bandits and apples

After the dangerous journey, including a very close call, the family landed in a refugee camp in Thailand. Food was scarce and conditions were bleak. Steve recalled drinking water so muddy it looked like coffee.

The fear of bandits, who preyed upon people like his family, was constant. And one night those fears became reality. Targeting their hut, the bandits beat Steve's father nearly to death, and also broke three ribs and beat his older brother. They took all their gold and valuables, the family escaping only with their lives.

The Yeng family spent five years in the refugee camp. His younger brother was born, so they were now a family of five. Steve's polio had never been treated, but he was able to crawl to get around.

He recalled the time his mother and father were able to purchase a delicious apple and stored it in a makeshift ice box. They ceremoniously cut it into three sections for the boys. They wouldn't take a bite because they wanted the boys to know the joy of an apple. Steve claims it was the most delicious apple he'd ever eaten.

At this point in our conversation a plane flew overhead. Steve paused and said that plane noise never bothers him, because at the camp when he saw a plane it meant freedom.

## Random acts of kindness

What is at the heart of his charity? Steve said simply, random acts of kindness. He and his family had been the recipient of so much kind-

ness, giving back is the only natural response.

Probably chief among these acts was a family from Ocean Beach, who decided to sponsor Steve's family anonymously. They were selected from a book of refugees, flown to the United States and all five lived in a garage in North Park. They ate lots of Top Ramen and bags of Red Delicious apples.

But they were in the USA! Yeng's parents took different jobs, finally landing in a donut shop, working for free to "learn the business." That donut shop was OB Donut. When it faced bankruptcy, his parents were able to round up enough resources to purchase it. You can still find them there every day on Sunset Cliffs Boulevard.

Steve recalled a group of regulars who helped he and his brothers learn English. He also talked about the people who helped while he went through multiple surgeries to try and repair the damage polio had done to his leg. Even though he lived in terrible pain for five years (and still suffers today), he laughed, explaining how he looked forward to the hospital with its cafeteria food and cable TV!

In the midst of this conversation, a Japanese beetle flew nearby. "I remember eating them with garlic powder, and salt and pepper," he said. "They're good!"

Steve still walks with a limp from the ravages polio wrought on his body, yet that never slowed him down or limited his drive. His businesses employs more than 160 people in Ocean Beach, of which, 90 percent live and work there.

He also helps subsidize some of his employees housing to make it affordable for them to live where they work. His generosity to Ocean Beach (and elsewhere) is often never known.

He is a shy, humble and joyful man and we are so very, very lucky to have him as one of our community champions!

# Pointers start quickly, hold on, for third straight win

Sometimes a "bye" in the season schedule helps a football team recover from moderate injuries, allowing numerous bruises and sprains to heal and generally return to a full roster of healthy bodies when the schedule resumes.

And sometimes, a team's momentum might be interrupted at just the time it is coming together to play its best football of the season.

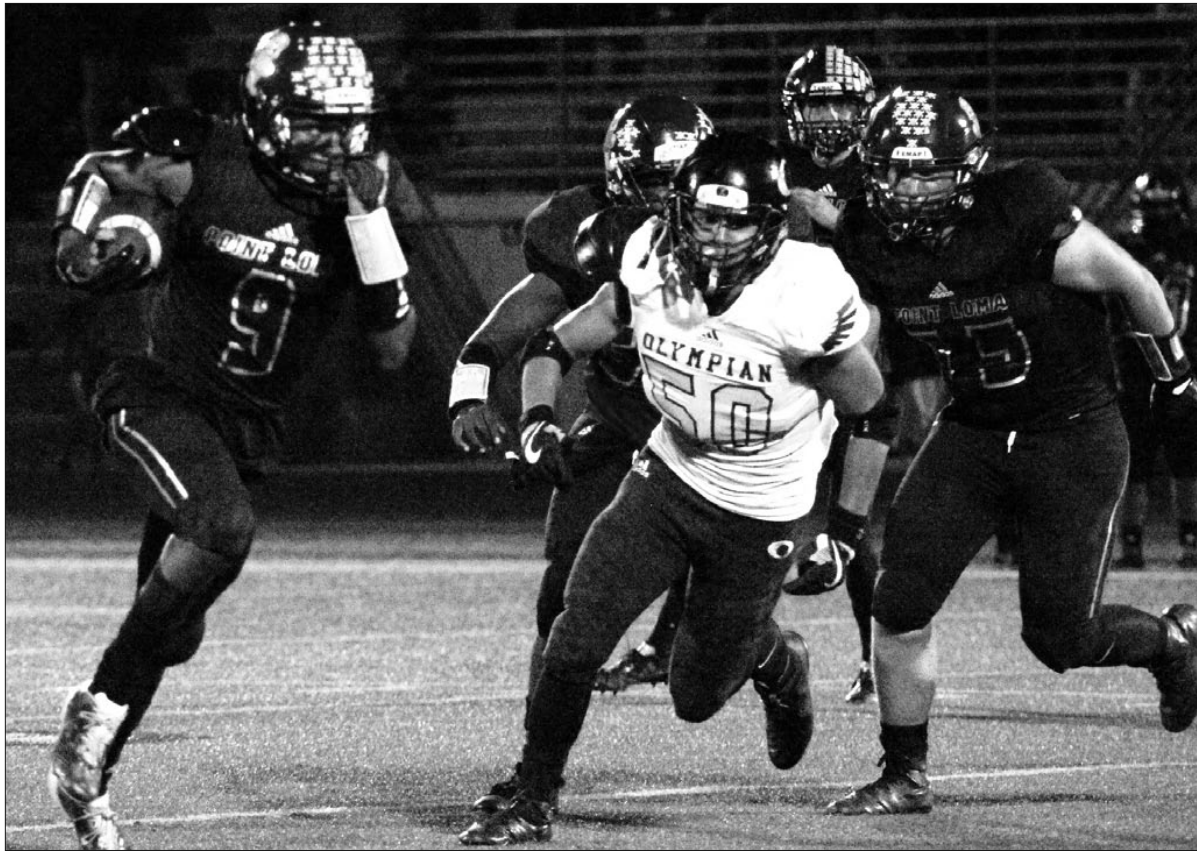
For Point Loma's Pointers, the latter may be most accurate to describe a team that has put together a three-game winning streak as it heads into the Western League season.

Last Friday night, it was a good Olympian High School team that took the field in Pete Ross Stadium with a 3-1 record only to see the hosts jump out to a 28-0 lead before they fought back to make a game of it in the second half.

"Our kids were in good spirits, they came to play," said Pointer head coach Mike Hastings later. "They digested the game plan the coaches taught all week really well. There was good energy in the air."

When the non-league contest ended, the Pointers posted a 38-28 victory to run their record to 3-2 while dropping the Eagles to an identical mark.

Over their last three games, the Dogs have scored 36, 50 and 38

points to average just over 41 per game after averaging just 13 in a pair of season-opening losses. And against the Eagles, they did it with big plays.

First it was JL Skinner, using his 6-foot 3-inches tall frame, to leap and grab a Kyle Grady pass before fin-

ishing off a 77-yard scoring play after the Pointers were penalized twice for holding.

Next was Malik Moore, who followed another holding call on the Dogs by running a sweep play with great blocking, that covered 90 yards, upping the lead to 14-0.

"I took the handoff," Moore said following the game, "and saw my boys had really good blocks, so I just took it and followed my blocking. They did it all and when I saw the hole, I just took off for the touchdown."

The play helped Moore lead all Pointer ball carriers with 138 yards, with Josh Ball adding 108 yards and Grady 82 to the team's total of 359. Grady threw for 183 yards for the game as the Pointers again totaled over 500 yards of offense.

Then before the first quarter ended, Ball finished a drive with a six-yard run good for a 21-0 margin before tacking on a 17-yard run in the second quarter for the big lead before the slumbering Eagles began to stir.

While the Eagles outscored the Dogs 28-10 the rest of the way, Grady's 59-yard run and a 29-yard field goal by sophomore Andy Medina kept the Eagles from soaring.

Medina was accurate on all five PAT's to give him eight total points in the game.

One of the Eagles' touchdowns came on a questionable call by officials, who ruled Moore was not legally down before a defender grabbed the pigskin from atop his chest and sprinted 93 yards for a touchdown.

"I ran the ball," Moore said, "my knee hit the ground and I rolled on my back. The defender took the ball out of my hands and ran it back. The ref said I wasn't down yet."

Fortunately, the play had no effect on the game's outcome.

"I'm real proud of our kids," Hastings said. "They finished the game the way they were supposed to. Now we have our league schedule ahead of us and a bye week to get ready for it."

The Pointers next take the field at Mesa College on Oct. 6 against league rival and nemesis St. Augustine. The Saints have only a 2-3 record but have played powers such as Canyon Springs (Las Vegas), Loyola (Los Angeles) and local Helix.

## Extra points

■ The Pointer JV team (2-3) beat Bonita Vista 48-12 before losing to Olympian 18-7. The freshman team (5-0) edged Bonita 8-6 and blasted Olympian 37-16.

■ Moore is considering extending his football career at several schools who have contacted him including USD, BYU, Sacramento State and possibly Columbia. He said he carries a 3.5 overall GPA with a 4.0 during his junior year.

## Barbara June Adams Thurber Harris

April 14, 1928 – August 15, 2017

Barbara J. Harris, known as Bobbie, died on August 15, 2017 at Harbor View Senior Assisted Living in San Diego. She was 89 and had been in declining health for the past year. Barbara June Adams was born April 14, 1928 in Los Angeles, California to Earl Francis Adams and Thelma Burd Creek Adams, who had moved to California from Missouri in 1924 with Bobbie's older brother Clifford Creek. Bobbie was a California girl and liked to say she was the same age as Mickey Mouse. She had red curly hair, and as a little girl, she and Shirley Temple took dance lessons together. While coming back from visiting relatives in Missouri when she was six years old, she was in car accident that broke her pelvic bone and required many surgeries. After graduating from George Washington High School in Los Angeles in 1947, she and her new husband Robert L. Thurber moved to Fallbrook in San Diego County, where he worked as a building contractor. They had two daughters, Cheryl and Christa, and settled in Point Loma in a house on Nipoma Street. When she divorced Bob Thurber, she worked for several years in the early 1960s as a small appliance demonstrator for General Electric and Westinghouse. From the late 1960s through the mid-1970s, she worked as a companion and caregiver for a schizophrenic woman with whom she traveled to Europe, Japan, and Hawaii. In 1973, she married Saul A. Harris, a liquor distributor with Simon Levi Co. Bobbie and Saul lived near Sunset Cliffs. They enjoyed entertain-

ing friends with gourmet cooking, traveling, and being grandparents together to granddaughters Phoebe and Chloe who visited every summer from Memphis, Tennessee. Bobbie loved to take friends and family to San Diego's many attractions and restaurants. After Saul died in 1992, she continued to travel on her own and for holiday visits with her family. She became a deacon and more active in her church. As a longtime member of the Point Loma Garden Club, she grew roses and orchids and was known for her flower arrangements. Bobbie enjoyed listening to jazz music. She expressed her sense of fashion and fun through her colorful outfits and jewelry. Diagnosed with breast cancer in 1985, she initially volunteered for the American Cancer Society's Reach to Recovery Program to counsel other cancer survivors through their recuperation. After the American Cancer Society opened the Discovery Shop in Point Loma in 1988, Bobbie was one of its earliest and longest serving volunteers. She worked in the shop almost every Tuesday for 27 years. In 1990, she created the shop's wig salon, where cancer patients knew that they could ask for Bobbie who would help them select a complimentary wig, hat or scarf. She was well known for her compassion and cheer in the wig salon. In a 2006 interview, she said "It's my payback because I didn't go through chemo or radiation." She also volunteered at St. Peter's by the Sea pre-school, where her daughter Christa worked, and Silver Gate Elementary School. With her red



curly hair, fashion flair, and large spirit of kindness, she inspired and brightened the lives of everyone she met.

She is survived by her daughters Cheryl Thurber of Baltimore, Maryland; Christa Thurber and her husband Richard Brown of San Diego; granddaughter Phoebe Evans Letocha, her husband Richard Letocha, and great-grandchildren Abby Letocha and Nathan Letocha, of Baltimore, Maryland; and granddaughter Chloe Evans and great-grandson Max O'Hearn of Memphis, Tennessee.

Services will be held on Saturday, September 30 at 11 am in the chapel at Point Loma Presbyterian Church (2128 Chatsworth Blvd. San Diego CA 92107), where she was a long time member. In lieu of flowers, the family suggests donations to either the American Cancer Society or to Alzheimer's San Diego.

Food service ends at 5:30 p.m. and at 6 p.m. guests will be escorted to their reserved seating on Bennie Edens Field in preparation for the kickoff.

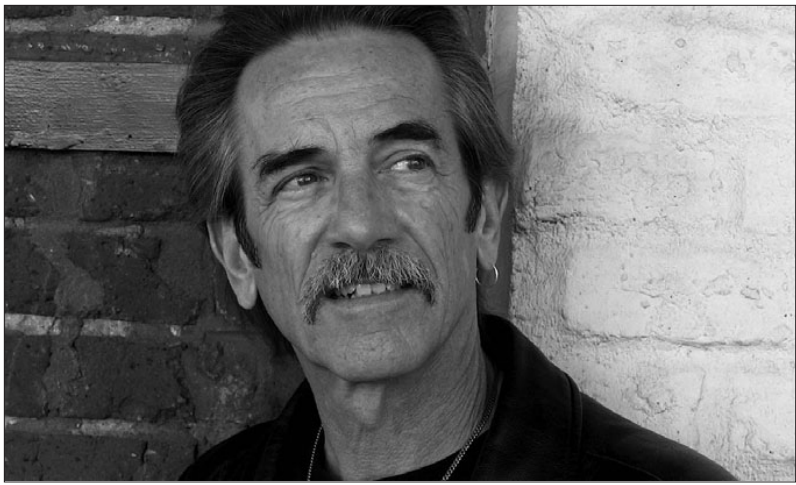

## Johnny Vernazza still slingin' it with 'Old Red'

San Diego is fortunate to have many music legends living in our midst, but few can match the accomplishments of blues guitarist Johnny Vernazza. His most recent album is 2014's, "Lions and Thieves," but he is best known for his time with legendary combo, The Elvin Bishop Group, and their timeless No. 3 1976 hit, "Fooled Around and Fell In Love."

The song is still a radio favorite,

turning up in commercials and movies such as the first "Guardians of the Galaxy" film, but it's just a small part of long, storied career that has seen him play guitar with everyone from Van Morrison to Jerry Garcia.

Appearing at Winston's in a special early show on Oct. 8, Vernazza has played intimate clubs and stadiums, but cites his TV appearances as the most fun live work he's done. "I've played lots of shows in my 50-some years at this and tons of them were

favorites, but I must say though that doing TV was the best," he said.

Vernazza was a mainstay of such 1970s era programs as "In Concert," "Rock Concert," "American Band Stand," "The Sonny and Cher Show" and the "Midnight Special," the latter of which he appeared on 14 times. "You not only are playing to a live audience, but when it's aired, more people see you than any one concert ever. They were a kick to film too, what a great experience and memory," he recalled.

According to Vernazza, he didn't choose the guitar as his instrument of choice. "It chose me," he said. "When I was 10, I started playing accordion. My dad and uncle played that instrument very well and were well-known around San Francisco as the Vernazza twins," he recalled. "My teacher was John Pezola and he was the brother of my dad and my uncle's teacher."

"Well, I would take my sheet music home and my dad and I would play. My ear was so good I just listened to my dad and faked my reading. This went on for about six months or so, until Mr. Pezola found I was giving the wrong value to my quarter notes. I was busted. He hit me on the back of the head."

Dad was called in and the young Johnny Vernazza was sent out of the room. "I could hear him yelling at dad in Italian, which was pretty funny. But, there was a guitar hanging on the music studio wall with some other instruments. When my dad came out I said 'can I play guitar instead?' Mr. Vernazza bought his son the guitar then and there. "That was the beginning of hitting strings instead of pushing and pulling bellows," he said.

Long-time fans will note that Vernazza has been playing the same two guitars for decades. "I've been with 'Old Red,' my Tele for 20 years now," he said. "It was built by a friend of mine and has a Strat neck and Humbuckers. I love the way it plays and sounds." Meanwhile, a friend built Vernazza a double cutaway Tele Thinline. "I use 'The Dragon' for all my G-tuning stuff. It's the fact that both guitars are handmade instead of store bought gives them some mojo that I love. They have a very special vibe, especially 'Old Red.'"

For his part, Vernazza is happy with his five decades plus of playing music. Future plans include a pair of books on his career, titled, "Why I Play."

"The artistic side of creating and playing music is my favorite thing, as well as all I know how to do and all I desire to do," he remarked. "It's a blessing and a curse that you learn to live with. You have to take the good with the bad and never give up. I think everyone has a different reason for being a musician, but for me it's all about the art, my art. I have no urge to sound like anyone else and will take my lumps because I won't," Vernazza said.

# Annual Cabrillo Festival set for Sept. 30 at Ballast Point

History comes to life at this free, family-friendly event at Ballast Point on Naval Base Point Loma on from 11 a.m. to 4 p.m. Saturday, Sept. 30.

The 54th annual Cabrillo Festival celebrates and recreates the voyage of 16th century explorer Juan Rodriguez Cabrillo, who, sailing under the flag of Spain, landed on the shore of San Diego Bay on Sept. 28, 1542, discovering California and all of the West Coast.

This pivotal moment in history is remembered every year with a series of events held by the Cabrillo Festival Inc. and the National Park Service.

There will be music, dancing, children's activities and foods from Native Americans, Mexico, Portugal and Spain. There will be Kumeyaay basket making, knot tying and a 16th century Spanish soldiers living history encampment.

Re-enactment of Cabrillo's landing from San Diego's historically

accurate replica of the San Salvador on Ballast Point begins at 1 p.m. Guests are advised to bring identification for entry onto the Navy base.

On June 27, 1542, Cabrillo set sail from Navidad on Mexico's west

coast with three vessels; San Salvador, La Victoria and San Miguel in search of gold and a route to the Orient and the Spice Islands. Sailing northwest into uncharted waters, they explored the west coast of Baja, California.

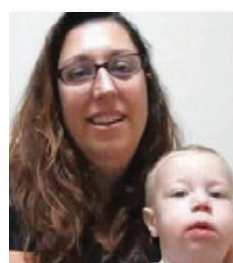

# SPAWAR plans to redevelop hanger complex near Old Town

In September, Space and Naval Warfare Systems Command dropped in to clue the Midway Community Planning Group in on early plans it has to redevelop its hangar complex near Old Town.

Based in San Diego, SPAWAR designs and develops communications and information systems, employing more than 12,000 professionals around the world and those of the United States Navy fleet. SPAWAR is one of the Navy's principal commands directly under the

Chief of Naval Operations. It is the Navy's technical authority and acquisition command for communications, computers, intelligence, surveillance and reconnaissance, business information technology and space systems. Eighty percent of the Point Loma Military Reserva-

tion evolved into the Naval Electronics Laboratory Center (NELC) at the end of World War II. In 1977, NELC was merged into the Naval Ocean Systems Center, and eventually was merged into SPAWAR.

Phil Brice, SPAWAR's director of command operations, characterized

the Old Town hangar complex as "a huge facility," adding, "Ninety-seven percent of SPAWAR is government civilians working to develop communications, both satellite and underwater. We're in the early stages of revitalizing our big hangars that run all through Old Town. We're seeking new facilities for that."

seven months to the coastal condo redevelopment.

“We’ve also established a GoFundMe.com account to help defray expenses in the fight to save the beach,” said Robert Tripp Jackson, a past president of the Point Loma Association, speaking on his own behalf.

Noting a “Save The Beach” account has been set up at Home Street Savings Bank on Rosecrans Street, Jackson added, “A coalition with four high-profile Peninsulans is being set up to oppose condos on the beach.”

Characterizing some aspects of the proposed beach condo redevelopment as “scary,” Jackson said underground parking, among other proposed changes, “would be extremely detrimental to that long stretch of beach, which has already suffered considerably from erosion, that is at least half a block long.

Described by some as Point Loma’s “hidden beach,” Kellogg, also known as Mother’s, is located behind Shelter Island in the La Playa area. It is a family beach and a popular area for boat watching.

The proposed condo conversion project, which fronts at 405 San Antonio Ave., was an information item at Peninsula Community



Peninsulans want to save Point Loma’s ‘hidden’ beach on the bayside.

Planning Board on Jan. 19. Project architect Mike Morton described the project site as being in a medium-density area surrounded by large, multi-family units and five single-family homes along the beachfront at the end of Lawrence Street.

“The project allows 13 to 20 units and we are proposing nine,” said Morton. “Rather than having a bulky building, we’re breaking it down into five smaller buildings. There will be underground parking with 21 spaces.” The La Jolla architect noted project ameni-

ties would include sustainable landscaping and use of photovoltaic (solar) power, along with an open view corridor and two elevators. He added the project takes into account anticipated future sea-level rise.

Peninsulan Howard Haimsohn, who is in the forefront of opposition to the condo redevelopment, noted this isn’t your garden-variety project because of its location.

“This is what’s considered to be a coastal beach,” said Haimsohn. “That is a significant issue because San Diego municipal codes do not allow you to build new development on coastal beach property. Coastal beaches have very special restrictions in place to protect the public’s interests and rights when it comes to beachfront property.”

Haimsohn stressed public opposition to the proposed Kellogg Beach condo redevelopment isn’t personal.

“We are not trying to restrict the developer’s rights to build,” he said. “What we are trying to do is make sure every concern of the California Coastal Commission and the city’s Development Services Department and all the various environmental agencies are met. We want to make sure everyone is heard clearly on this, and that all the codes are strictly adhered to. That’s the public’s expectation — and right. That’s the main focus of what we’re trying to do.”

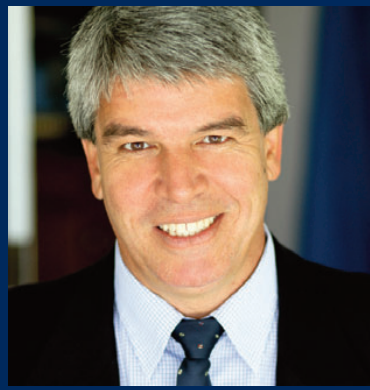
