## Teen accused of killing 'Incense Man' gets bail set at \$2 million

A 19-year-old man pleaded not guilty Feb. 23 to the 2017 murder of Walter (Ras) Riley, a well-liked transient known as "Incense Man" in Ocean Beach.

Noah Mitchell Jackson appeared in blue jail clothes before San Diego Superior Court Judge Maureen Hallahan.

"Bail will remain as set at \$2 million," ruled Hallahan after attorneys submitted the bail issue without any arguments about bail.

Deputy District Attorney Michael Reilly said Jackson faces a maximum sentence of 26 years to life if he is convicted of first-degree murder.

Riley sold incense at the weekly OB Farmers Market and along Newport Avenue during the week, which accounts for his nickname.

Just before 12:30 a.m. on June 22, 2017 a 911 caller reported that one man was attacking another in the 1900 block of Bacon Street, San Diego police homicide Lt. Todd Griffin said. Responding officers found Riley lying on the sidewalk with stab wounds to his upper body. Riley was taken to the UCSD Medical Center where he was pronounced dead.

Surveillance camera footage from a nearby business showed a man wearing a grey or white hooded sweatshirt leaving the area. The photo was published by media and TV stations and a \$1,000 reward was offered for his arrest.

Jackson was located at a medical facility in Huntington Beach, and was arrested there on Feb. 20.

A preliminary hearing was set for March 8. Reilly said it would likely be delayed at another hearing March 6.

## Competency hearing ordered for accused sledgehammer killer

Criminal proceedings were recently suspended for a man charged with killing a 37-year-old man with a sledgehammer near a bus stop on Midway Drive.

The attorney for Greg Jennings, 50, told San Diego Superior Court Judge Jay Bloom he was not sure Jennings was mentally competent to understand court proceedings.

A psychologist was appointed to evaluate Jennings in jail and file a report before March 28 when Jennings will appear before a judge in a mental competency hearing.

Deputy District Attorney Michael Reilly said the victim is not being identified as relatives have not been notified. The medical examiner's office has not issued an official cause of death pending notification of his family.

If a judge finds Jennings to be mentally incompetent, he would be sent to a state psychiatric hospital for treatment and returned here to face criminal proceedings. The Feb. 22 preliminary hearing was canceled.

Reilly said he did not know if Jennings knew the victim, but they had been arguing about 6:20 p.m. on Jan. 8 near a bus stop on Midway Drive near West Point Loma Boulevard.

The sledgehammer was small, weighing 64 ounces, but the victim was struck multiple times before he collapsed.

Jennings is behind held on \$2 million bail. He has pleaded not guilty.

## Former Point Loma Navy man, suspected of killing wife, receives \$2M bail

Bail of \$2 million was set for a former Point Loma man suspected of fatally stabbing his wife, whose body was found in San Diego Bay in 2016.

Matthew Scott Sullivan, 32, pleaded not guilty to the murder of Elizabeth Sullivan, 32, who was last seen alive Oct. 13, 2014.

The decomposed body was found Oct. 6, 2016, two years later, said District Attorney Summer Stephan, outside of San Diego Superior Court.

The body was found at the edge of the bay at 2600 Farragut Road, said Stephan, who noted that the body was found two years later on the same day that Sullivan was moving out of military housing in the Liberty Station area.

The residence had been searched earlier, she confirmed, but a knife was found hidden in the attic in the home where she and her husband lived with their two children.

Matthew Sullivan was arrested Jan. 31 in Delaware after a judge issued a warrant for his arrest. The two girls, aged 5 and 7, are now in the custody of their mother's father in Virginia.

"It may take time but we will not forget victims," said Stephan. "We know that many suffer in silence."

"Being in an intimate relationship should not hurt," said Stephan. "Mrs. Sullivan was in the midst of leaving him, but did not have the chance."

Murder is the "ultimate form of domestic violence," said Stephan. "Domestic violence is often repeated violence over time. No one is immune to domestic violence."

Judge Maureen Hallahan ordered Sullivan to next appear March 1 for a status conference to set future court dates. He remains in jail.

If convicted, he faces a sentence of 25 years to life for first-degree murder.





# Controversy and confusion with recycling center on Voltaire St.

Confusion reigns following a February community rally seeking to have Prince Recycling Center, adjoining Stump's Family Marketplace in Point Loma, moved to a more suitable site in nearby Midway District.

Two days after the rally, Prince was reportedly served with an eviction notice by the marketplace's property owners. Meanwhile, Midway planners turned thumbs down to the proposal to relocate Prince Recycling Center to their neighborhood.

A week later, some Peninsulans alleging the recycling center is a homeless haunt, a community blight and a crime catalyst, pled their case for removing the Point Loma "convenience" recycler to Assemblyman Todd Gloria at a Feb. 17 community town hall.

Add to all that frustration on the part of marketplace owner Dirk Stump, who was compelled by state

law four years ago to allow a "convenience" recycling center onsite next to his market at 3770 Voltaire St. — or face daily fines.

Stump feels increasingly pressured — and trapped in the middle — by this most recent turn of events with Prince Recycling.

"There's very little [else] I can do about it, and I've been working on [removing] it for 1 1/2 years," said Stump. "My full-time job is running a supermarket. I'm not a legislator or a lawyer."

Stump is seeking a land-use attorney to help guide him through the legal morass that has developed over the recycling center adjoining his market.

"Prince doesn't have a lease," said Stump, who added, Prince Recycling is bad for his business. "It's doing nothing for me," Stump said. "I've got to contend with the bad clients that come in."

Stump believes the Feb. 10 public rally against the recycler did more harm than good.

"It would have been easier if things were under the radar," he said. "But if the spotlight is on you, you can't get anything done, other than people's feelings getting whipped up."

"I can't fight the state," Stump said. "This is my livelihood."

Sacramento-based Aaron Moreno, senior director of government relations for the California Grocers Association, believes state laws governing recycling need to be amended to reflect changing times.

"The state law requiring recycling

centers to be tethered to supermarket parking lots was written back in 1986," Moreno said, noting about 300 recyclers statewide were forced to close a couple of years ago due largely to increased labor costs and declining market prices for recyclables.

"Now, you have these situations with recycling centers where you're getting pressure both from local government and community groups," Moreno said. "Curbside recycling is now much more commonplace. We need to rethink the size of convenience zones, enlarging them from a half-mile radius."

Pointing out grocers typically operate on slim 1- to 2-percent profit margins, Moreno said that puts grocers "between a rock and a hard place."

Jon Linney, one of several community advocates organizing for Prince's relocation, said, the goal "is to help the community find a better site for a recycling center, one that best serves the needs of all parties,

and that is not adjacent to a residential area.

"We are not seeking to cause financial harm to Jamie Prince of Prince Recycling, nor are we a party to any eviction proceeding. Our understanding, after speaking to the various parties, is that Mr. Prince has not paid rent, may never have received written permission from the landlord, and could be evicted at any moment."

Another co-organizer of the February anti-recycling rally, Margaret Virissimo, weighed in on the matter.

"At this point, it is up to the owner of Stumps to get the recycle center moved into a civil court matter and request an official document to be served to the owner of Prince Recycling," Virissimo said. "The community members are the ones that need to stand up now and voice their concerns."

"It is the clientele and crime that a recycling center brings near homes and schools that is the problem," she said. "We have many reasons why we would help relocate the recycle center to a safer, larger space that can service three gigantic communities Point Loma, Ocean Beach and Midway."

After repeated attempts, James Prince of Prince Recycling did not return calls by the Peninsula Beacon for further comment.

# Have more parrots made Ocean Beach their home? Experts say 'yes,' 'no,' 'maybe'

There's a perception as of late by some in the Peninsula that parrots are proliferating prodigiously.

True?

"No, not really," said Brooke Durham, founder of SoCal Parrot, a Jamul rescue group that went high-profile a couple years ago when OB parrots were killed by pellet guns.

Durham speculated the previous illegal culling of parrots has conditioned Obecians to being more aware of the presence of the exotic birds in their community. She noted it's been almost exactly two years since the spate of OB parrot killings when "half the community was outraged."

The culprit(s) in the parrot killings was never discovered.

"I think more people are aware that they [parrots] are here," Durham said, adding parrots exhibit a seasonal migratory pattern.

"We have heard complaints, but also, we have heard lots of people who absolutely love the parrots and identify the parrots with OB," said Denny Knox, executive director of Ocean Beach MainStreet Association. "There are many more parrots who are making OB their home. I've never seen so many parrots at any one time."



"We do know the Amazons (parrot species) reside in East County in the late summer through early winter, after which they return to the beach areas," Durham said. "There might be an uptick in the amount of birds overhead right now." Durham added, more birds being seen now may be a function of seasonal migration and not "a massive population explosion."

Berlant and Vincent Peppard, co-owners of Tropic Island Bird and Supply at 4760 Voltaire St., were divided over whether or not there are more parrots around now than ever before.

"Definitely not, Amazons, they come and go," said Berlant.

"Yes, there seem to be a lot more," countered Vincent. "Of course, that's not scientific. But it seems there are more of them around this time of year."

There's one thing both Peppards agree on: There are more parrots clustered in East County at certain times of the year usually, than along the coast.

"I've seen parrots in flocks of 100 birds in East County," noted Vincent.

Berlant agreed parrots are more preponderant inland. Though she was quick to point out there are "28 different varieties of Amazons" in San Diego.

Durham noted it is a commonly held misconception that Amazon parrots are native to San Diego. She said many of the birds have migrated north, one way or another, from Mexico, mostly to escape encroachment on their natural habitats.

"The climate is mild here," she said, pointing out another reason why San Diego is attractive to the bird species.

"The food parrots eat is in our yards, even some of our bushes and [flower] blossoms that we don't think of as having food for birds," she said.

Added Durham, much of the native vegetation, like the California Coastal Sage Scrub along the coast, does not harbor any food sources for parrots. That's another reason, she speculated, for why the exotic birds are not seen as much on the coast as they are inland, where wild fruits are more available to them.

# Midway planners refute recycling center relocation

On Valentine's Day, Midway Community Planning Group nixed proposed relocation of a recycling center into their neighborhood, while questioning numerous items in an inches-thick environmental report for Midway's Community Plan update.

On Feb. 10, a rally was held at Stump's Family Marketplace in Point Loma opposing Prince Recycling center being there, advocating the recycler move to Midway District behind Big Lots off Rosecrans Street. State law requires recycling centers to be located within a convenience zone, typically a half-mile radius circle with the center point originating at a supermarket.

"There is a movement to remove

the recycling center from Stump's because of the homeless/criminal issues they're having, and their solution is to dump it in Midway," said MCPG chair Cathy Kenton. "That's nimbyism at its worst."

Kenton was miffed Peninsulans suggested moving the center to Midway "without asking for any comment from us, just arbitrarily picking a location which is outside their required (half mile) radius."

Peninsula Community Planning Board liaison Jim Hare pointed out Prince Recycling Center at Stump's "has never been an agenda item."

Kenton noted proponents of moving the recycling center are lobbying Assemblyman Todd Gloria to expand the radius of convenience center recycling to allow Prince's Recycling at Stump's to be moved.

# Find comics, costumes and figurines at Comickaze Liberty Station bookshop

Robert Scott, owner of Comickaze in Liberty Station, described his browsable comic shop as being like a bookstore, only cooler.

"It's not a library, we don't want people pulling up a chair and reading," Scott said. "But yeah, browsing ... how are you going to know if it's something you want to take home and read?"

There are literally thousands of individual items, comics, books, figurines, costumes, posters—you name it, stacked floor-to-ceiling in Scott's sprawling retail space at 2750 Historic Decatur Road, Suite 101.

The entrepreneur has been in the comics business for 27 years. Having started in Clairemont, he is now branching out.

"We came to Liberty Station looking to expand," Scott said. "We wanted to get out into the neighborhoods, not force people to drive all the way to Clairemont."

Scott said Comickaze had a fair amount of customers who lived in the Peninsula area. "We also have friends at IDW Publishing, which opened their comic gallery right across the way," he said. "So we thought it might be a good collaboration."

Comickaze moved into Liberty Station, opening on Halloween day 2015.

Comickaze, according to Scott, is actually a full-service bookstore. "Anything you could buy at Amazon, or Barnes & Noble—you can buy here," he said. "We thought it would be nice for Point Loma to have an alternative bookstore."

Scott also enjoys "being in the arts district here in Liberty Station among all the artists." And, if a customer wants something Scott doesn't have in stock, he'll special order it.

Strolling through Comickaze, items are organized alphabetically, according to categories. There's a section for kids age 12 and under with non-violent choices. There's a huge selection of graphic novels, which Scott noted are actually comic books that have been collected into book form.

The history of American comics dates back to 1842 with the trans-

lation of Rodolphe Topffer's work, "The Adventures of Obadiah Oldbuck." But it wasn't until daily newspapers and comic strips, that the art form really took off. American comics' historians generally divide 20th-century American comics history into ages: the Golden Age from 1938 (first appearance of Superman) to 1954; the Silver Age from 1956 to early 1970s; the Bronze Age spanning from then until 1986; and the Modern Age, from 1986 until today.

The industry has evolved a lot from where it started.

"Comic books were meant to be a disposable entertainment," Scott said. "You were supposed to throw them away when you were done with them. They were so cheap. And they were printed on cheap paper. They weren't meant to last."

Asked why comics are appealing, Scott said, "It's visual, something that goes with your senses that you wouldn't normally get with just a traditional book."

Comics are also timeless, noted Scott, pointing to his clientele.

"I have parents and grandparents bringing their kids and grandkids in here and getting them started reading."

# New bike share businesses roll into beach communities

Walking to a destination has now become passé. San Diegans are rolling, as three new bike share businesses are now peddling their dock-less cycles in the City.

LimeBike brought out its bright green bicycles on Feb. 16, making it the first dock-free bike share business to launch in the City. Soon after, Ofo planned to begin deploying its yellow bikes to share. And on Feb. 23, Mobike rolled out its signature silver-and-orange dock-less bikes to locations in San Diego.

LimeBikes are GPS and 3G-enabled, making it simple for riders to find, unlock and pick up a nearby bike using their smartphone. When finished, riders simply lock the bike's back wheel and responsibly park between the pedestrian-designated sidewalk and the street curb, or at a bike rack.

Since first launching in LA last

November, Ofo has seen a positive response from folks who have welcomed a greener and more affordable way to travel. How it works: Open the app and find all the bright yellow bikes around you. When you're at the bike, tap "unlock" and scan the barcode to automatically unlock and enjoy the ride. Simply park your bike and manually lock it to end the trip.

San Diego becomes Mobike's fifth U.S. market, and adds to the company's global expansion into more than 200 cities and 12 countries in less than two years.

Using specially-designed bikes equipped with GPS and proprietary smart-lock technology, Mobike enables users of its smartphone app to find a bike near them, to reserve and unlock it.



## Pointer girls win school's first water polo title

The Point Loma High girls water polo team accomplished what no Pointer team had before when they defeated No. 3 seeded Mt. Carmel 6-3 to win the CIF Div. III championship last Saturday.

The Pointers had previously been awarded the No. 1 seed and a first-round bye after posting a 16-8 regular season record that included a 9-1 record in the Central League that tied them for first place with Mission Bay.

The road to the title for Point Loma included wins over No. 9 Mira Mesa and No. 4 Mission Bay.

The team will now have an opportunity to advance in the CIF state regional tournament with the No. 8 seed Pointers scheduled to face Div. II top-seed Laguna Beach at 4 p.m. March 2 at Corona del Mar High School. Both semifinals and finals are set for the next day.

"The key to this year's team was commitment," said head coach Ken Toma, still dripping after ceremoniously being thrown into the pool by his players following the match. "At the start of the season, I looked at our division and I told [the girls] they could be in the top four and in the mix for a championship. I sold them on the idea that if they worked extremely hard they could get there."

The Pointers and No. 3 seed Sun Devils had met twice before during the season including Pointer wins of 5-2 and 6-0, both during early-season tournament play.

But, ironically, it was Mt. Carmel

drawing first blood with a goal early in the first of four seven-minute, stop-clock quarters that comprise the high school game.

The lead didn't last long.

Pointer senior Shelby Smith evened the score early in the second period before assisting on the second Pointer goal to give her team a 2-1 halftime lead. Smith's goal was the first of five straight Pointer goals before the Sun Devils scored in the third period to reduce the Pointer lead to 5-2.

The game became tense briefly in the final period when the Sun Devils trimmed the lead to 5-3, but the Pointers quickly answered to restore their three-goal lead and put the

game away.

Senior Kristen Smith (no relation to Shelby) had consecutive goals in the third period and Aja Whittaker added a pair.

In goal, Tanner Monette made eight saves. She is headed to Cal State Monterrey Bay where Toma feels she has a good chance to play.

Members of the team also include Alexia Stroud, Katie Power, Janel Sytko, Jane Lubsen, Nyoka Martinezcuello, Eloise Lubsen, Tavaya Martinezcuello, Angelina Myers, Teresa Grippo, Veronica Divis and Camille Sytko.

For the season, the champion Pointers scored 230 goals, while allowing only 124.

Bicycle riders are prohibited on trails at Sunset Cliffs

Dear Editor:

Thank you for the lengthy article in the recent Peninsula Beacon regarding Sunset Cliffs Natural Park. Gene Berger, chairman of the Sunset Cliffs Natural Park Council, told us about all the dog walkers and activity which is “pretty detrimental,” but not once was the word bicycle or bike mentioned. One bike tearing up the trail does more damage than a hundred dogs may do in a year. Bicycles are prohibited from Sunset Cliffs Natural Park yet they are there daily.

“Bicycles prohibited on all jogging, walking paths or other park areas not designated for vehicle use. S.D.M.C. 63.02.19.”

I was surprised that apparently you did not speak with anyone from SD Park and Rec. or the park rangers. The San Diego Police told me that they cannot cite the bikers or enforce the code because the existing signage is insufficient. They say there must be adequate signage to properly notify the public. This means a sign at every entrance or access point to the park.

There are at least 11 south of Ladera Street alone. Most of the existing signs cover alcohol, glass

containers, smoking, noise, fires and dogs, but not bikes. The few existing no bike signs have been vandalized and are unreadable. San Diego does not maintain its park signage properly so the rules are not enforceable.

Bikes are not only tearing up the trails and other areas, but are a significant safety hazard to all who use the park. A biker roaring down a single-track trail is a serious danger to anyone on the trail.

Due to social media, more and more bikes are using the park all the time and it is getting worse. San Diego Magazine in its annual Trails issue mistakenly urged its readers (referring to Sunset Cliffs Natural Park) to, “Join the packs of bikers on this path and do some people-watching. The park is away from traffic with a network of trails for further exploring.”

Without proper signage and enforcement, this problem will continue and grow worse. It is only a matter of time before there is a serious incident or tragic accident if nothing is done. I urge you to help to correct this situation by making your readers aware of your oversight in this article. Seniors, mothers and children are at serious risk, but so is Sunset Cliffs Natural Park.


