Judge hands out sentences to 4 of 5 Bird Rock Bandits

Jail time ranges from 349 to 90 days

Moments before a judge tossed four men in jail Friday for their roles in the death of La Jolla surfer Emery Kauanui, Jr., he asked them to turn around and face the 100 people in the courtroom audience.

“Look who you let down and don’t you ever forget it,” said San Diego Superior Court Judge John Einhorn. “These people would want to be anywhere else in the world except here.”

Before they were led away by sheriffs deputies, Einhorn placed all four men on three years probation with the condition they abstain from drinking alcohol even in their own homes after they are released from jail.

“Alcohol has been part and parcel for what you did,” Einhorn told the men. He added they were “fueled by alcohol” and “engaged in a herd-like mentality” when they surrounded Kauanui on May 24, 2007, in front of his mother’s home in La Jolla.

Einhorn said it would have been easy to send the men to prison, but he thought each sentence “needs to be uniform” with the role they each played. He said he was only imposing probation for these four because the evidence showed it was a fifth man, Seth Cravens, 22, whose punch to Kauanui’s head caused the fatal injury when he hit the pavement.

Eric House, Orlando Osuna and Henri “Hank” Hendricks appeared to pray silently shortly before the sentencing began.

Osuna, 23, got 349 days in jail, the longest term of the four. Osuna pleaded guilty to involuntary

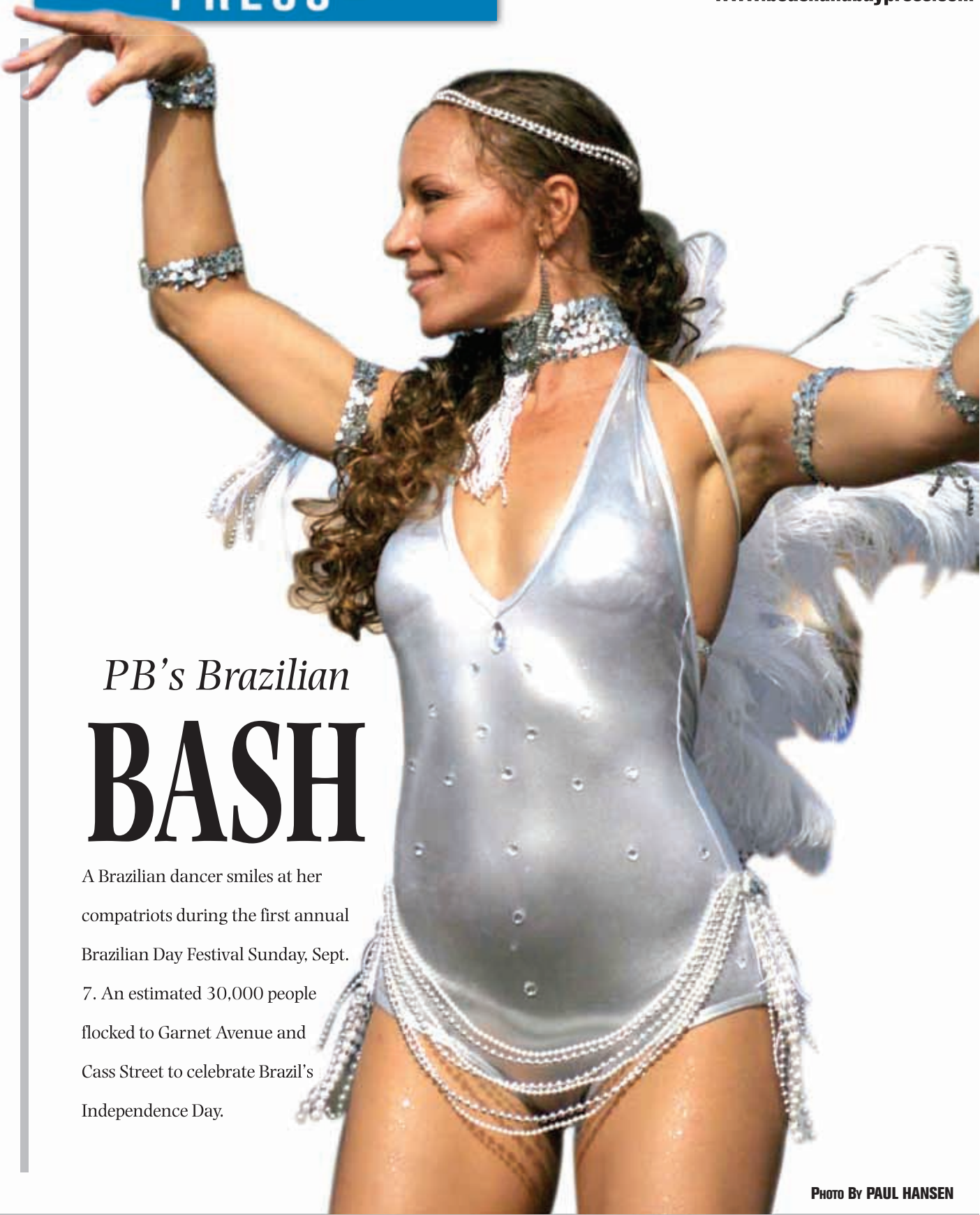

San Diego’s organic farmers help feed Pacific Beach

The popular movement toward eating locally grown organic, farm-fresh foods has been touted by healthy eaters and environmentalists alike for years. Now because of rising fuel prices, it could be cheaper to buy local, adding further incentive to buy, sell and eat local produce.

Farms such as the Tierra Miguel Farm in Pauma Valley can provide healthier, cheaper organic produce during peak seasons, according to farm director Beth Ann Levensdoski.

The farm doesn’t have to spend as much on transportation costs, allowing it to sell produce up to 30 percent cheaper than a

local supermarket carrying similar organic produce, she said.

The Tierra Miguel Foundation has been partnering with sites around the city — including Pacific Beach — to bring the organic food to consumers through a Community Supported Agriculture program.

The 9-year old program sells food locally, emphasizing the connection between local farmers and consumers “to bring integrity back to the food relationship,” she said.

It’s a connection not lost on one local business owner.

Nick Zanonni has opened the doors of the Pacific Bean Coffee shop, 712 ½ Garnet Ave., as a center where customers can pick up the organic produce from Tierra Miguel

delivered each week. Any leftover food goes to local church charities.

Zanonni is also involved in another organic farm in Athens, Ga., and uses environmentally friendly practices at his Pacific Beach businesses.

He said it’s important to be able to look your farmer in the eye.

“You get your haircut at some place in particular, right?” Zanonni asked. “I think people will start to realize the importance of who grows their food and who feeds them.”

He said he wants to make the journey from “seed to plate” easier for Pacific Beach residents at a time where the food travels more than a thousand miles before reach-

ing the dinner table, incrementally damaging the environment and raising transportation costs.

The Food Program

Anyone can sign up for a weekly or biweekly organic grocery program and is encouraged to sign up in advance. “Full Shares” cost about \$700 and half-shares cost \$350 for the season, which lasts 16 weeks. The farm also has a market at the farm itself in Pauma Valley.

“The biggest complaint I have from people that are members is that there’s too much food,” Zanonni said.

Combined with organic food donations through Thrusters Lounge at 4633 Mission Blvd., Zanoni also donates any extra food left behind to help local churches feed Pacific Beach homeless.

Programs such as the Wednesday night Ministries of the Pacific Beach United Methodist Church, 1561 Thomas St., help take care of some of that extra food.

Every Wednesday the church feeds about 200 of the city's chronically homeless and provides free medical and dental services through the UCSD student-run clinic, said Marry Herron, board chair for the Welcome Door Foundation.

In cooperation with the church, Herron said her group still provides food as part of the group's mission regardless of complaints about more than 100 homeless people gathering in Pacific Beach every Wednesday.

"I'm sure it is inconvenient [for neighbors]. But I think feeding the hungry is a responsibility of everyone. Nobody should be hungry in our country," Herron said.

She said it costs about \$300 to provide a hot meal for about 200.

The organic food donations from Zanoni's business account for a small part of the total food prepared by the church, Herron said.

The Farm

The 85-acre Tierra Miguel Farm can label its produce organic

because it doesn't use pesticides or sell genetically modified ingredients.

The farmers also use biodynamic practices. Such practices include recycling a lot of the nutrient-rich compost material back into the soil and monitoring the soil to make sure nutrients are “balanced,” Levendoski said.

Through the program, shareholders get a box of seasonal produce approved by California Certified Organic Farmers (CCOF). The CCOF follows United States Department of Agriculture National Organic Program standards to certify produce as organic.

According to the USDA, products labeled organic must contain at least 95 percent organically

produced ingredients. Produce grown using methods including some pesticides, sewage sludge and radiation cannot display the official organic label, according to USDA documents.

The organically grown fruits, veggies, herbs and other foods from Tierra Miguel Farm vary throughout the year, but this fall's harvest would include squash, zucchini, pumpkin, tomatoes and cantaloupe, Levandoski said.

The farm also produces educational programs to inform students and other farms on the benefits and methods of producing local organic foods.

manslaughter and three misdemeanor battery charges involving injuries to three people at a New Year Eve’s party he crashed in 2006 at a Mount Soledad house. He was fined \$1,114, and received credit for spending 54 days in jail before his family posted \$500,000 bond.

Eric Matthew House, 21, got 210 days in jail, with credit for 19 days previously spent in jail before his parents posted \$1.5 million bond. House pleaded guilty to involuntary manslaughter and was fined \$1,054.

Matthew Yanke, 22, also got 210 days in jail, with credit for three days spent in jail before his family was the first to post \$1 million bond for him. Yanke pleaded guilty to involuntary manslaughter and misdemeanor battery to one person who was injured at a 2006 party. He was fined \$1,074.

Hendricks, 22, received 90 days in jail, with credit for seven days before his parents posted \$500,000 bond. Hendricks pleaded guilty to being an accessory after the fact. He was fined \$1,054.

Cravens did not appear with the others Friday and will stand trial for murder on Oct. 14. He remains in the George F. Bailey Detention Facility on \$1.5 million bail. All five men are graduates of La Jolla High School.

“Nobody won, guys,” Einhorn said. “Each of you, show your community, your families, the memory of Emery Kauanui and this court that I haven’t made a mistake on this sentence (with probation).

“I will retain personal jurisdiction. If you violate probation, you’re going to prison. It takes one screw up to get back to me,” Einhorn said. “The key to prison will be given to you.”

The judge ordered all four men to stay away from Windansea Beach for the next three years to avoid running into other surfers who might have known Kauanui. He ordered them to stay away from the La Jolla Brew House, where the incident began.

Kauanui fought with House at the Brew House and spilled beer over his head. Kauanui had also been drinking, and his blood/alcohol level at the hospital showed he was intoxicated. His girlfriend, Jennifer Grasso, drove him to his mother’s home, but the five men later showed up outside. The fight began when Kauanui confronted the men in front of his house.

Einhorn also barred the men from contacting 17 people he named in court, which included the victim’s family members, witnesses and people who were injured at parties that they have crashed.

He described the group as “a bunch of bullies that together think they are tougher and smarter.”

“You didn’t do a damn thing to help (Kauanui). Had one of you decided not to go (to Kauanui’s house), we wouldn’t be here,” Einhorn said.

The judge said he imposed probation because none of the men had prior criminal records. The assault and battery charges that involved crashing parties and punching people were only filed after Kauanui’s death. The group became known as

the Bird Rock Bandits, and people had called police about being attacked and threatened by the men, but their identities were not known until later.

Einhorn also ordered each one to pay \$1,127 to the probation department for costs in preparing probation reports. The probation department recommended all four men be placed on probation, with jail time and restrictions.

Hendricks’ attorney asked the judge about a sentence with work furlough, but Einhorn stopped him firmly, saying, “They’re not going to (get) work furlough.”

Yanke, Hendricks and Osuna told the judge they had remorse. Yanke has been staying at a sober living facility since he was released from jail, his attorney said. House was overcome by emotion and close to tears and did not speak.

“This isn’t about me. It’s about the death of my friend, Emery. I take full responsibility for what I did that evening,” Yanke said. “He was a loyal friend. I let him down that night. I’m very ashamed about that.”

“My life has changed forever. I take full responsibility for my actions,” said Osuna. “Not a day goes by I don’t think about Emery. My lifestyle has changed.”

“I go to church and pray for his soul every day. Not go to church, but pray,” Hendricks said. “I accept full responsibility for being there.”

Deputy District Attorney Sophia Roach sought prison terms for House, Yanke and Osuna. Roach showed a video of photos of Kauanui at various ages with an audiotape of 911 calls made by his neighbors when they saw him being beaten.

The video also included photos of Kauanui surfing, hanging out with friends and his girlfriend. The family’s sobs were heard in the audience as it was playing.

“Emery is my treasure, the love of my life, as his mother. Thank God I had him for 24 years,” his mother Cindy Kauanui said tearfully. “My life has not been the same. I don’t know how long my heart will take to heal.”

“I’m a little insulted these people are calling Emery a friend, considering I’ve never met them in my life,” said his brother Caleb Alimboyoguen.

“We were given a life sentence. I lost the love of my life, my soulmate,” said Jennifer Grasso, the victim’s girlfriend. “I was screaming. I was kicking them to get these guys off Emery.

“Maybe their intent was not to kill him but to hurt him. Maybe they’re remorseful, but they may be concerned how it affects their lives,” she said.

She thought the PB Historical Society might like a railroad spike she found in Rose Canyon and a chair arm from the Roxy Theater. I don't really have a place for them either, so I'll be happy to pass them on to the first person who contacts me at one of the numbers below.

Artistic Licenses: "NO CUDA" was on a vintage Dodge muscle car —apparently not a Barracuda. The interesting thing to me was that it was one of the really old black Cali-fornia plates with gold letters. I did not think personalized plates were available in those days. I enjoyed the license plate frame that said, "You gotta have balls to play golf the way I do." "GOLF BRAT," sadly, was on an entirely different car.

25 Years Ago: Roger Hedgecock celebrated 100 days in office as San Diego's 30th mayor on Sept. 1, 1983, noting that he was "pleased with his accomplishments" and hopeful of continued success "because of his willingness to work with City Council members and community leaders."

50 Years Ago: A sailor, racing his motorcycle at more than 90 miles an hour, was killed in Mission Bay Park, on Sept. 1, 1958. According to the Evening Tribune, the accident took place "east of Lapwai Street and north of the flood control channel" in an area used by motorcycle riders for high-speed runs. I'm wondering how far east the flood control chan-nel went in 1958, because Lapwai Street — when it existed — was north of the Sports Arena in an area where I-8 is today.

ArtWalk paints a pretty picture for SD schools

If you're already familiar with ArtWalk – and unless you spend your springs in Nome, you've heard of it – you probably know something about its seasonal cousin. ArtWalk on the Bay, patterned after the outdoor fine arts festival that brings Little Italy to a halt one weekend in April, is set to run Saturday and Sunday, Sept. 13 and 14 at Embarcadero Marina Park North downtown. Founded in 2006, ArtWalk on the Bay will feature the work of more than 100 artists whose pieces are for sale and whose creators are always eager to meet their new patrons.

The festival gets a lot of mileage from the original ArtWalk, which boasts an annual attendance of six figures – but it also spearheads a community service targeted at a captive audience nine months out of the year. ArtReach, begun last fall at Garfield Elementary School in North Park, offers a visual art experience to kindergartners through sixth-graders throughout San Diego County.

"ArtReach is a logical outgrowth of ArtWalk," ArtWalk managing director Sandi Cottrell said. "ArtReach is ArtWalk's way of giving back to the community by addressing the great need for art education in the schools. We believe art is a necessity in children's lives, not a luxury."

Wholesale study results reflect that children learn more quickly and retain information longer when the arts are involved in their curricula. For program founder Cottrell, those results translate into real-life interactions in the classroom.

"You can really identify the kids

who've had some art in their lives," Cottrell said, "whether it be from an after-school program or from their parents at home or if they've had teachers that teach them art. They're very confident and comfortable. They pick up the materials and start creating.

"You see kids who are clearly very uncomfortable and say, 'I don't know how to do this,' 'I can't do this'; we do try to make those children comfortable in the short time we have with them.

"As we go forward," Cottrell said, "we'll expand the curriculum a lot. [This month], we'll be looking at different activities we can do with the children. The first year was really going into the schools and looking at the logistics, how we keep the kids from having blue faces at the end of the day."

ArtWalk on the Bay has its younger attendees covered as well, chiefly through KidsWalk. This area offers hands-on educational art

activities for youngsters and their families, including participation in a drum circle and creation of an art project made of recyclable materials. There's also a kite-coloring project wherein the finished product is donated to an orphanage in Mexico.

Meanwhile, Cottrell said, ArtReach intends to found a scholarship program.

"To this point, we've had to charge the schools," Cottrell said. "As we have increasing funds, we'll be doing scholarships for schools that can't afford it."

This year's ArtWalk on the Bay will feature two entertainment areas with live music, featuring acts such as The Coyote Problem, Jordan Reimer and Kim DiVine. And "Artes de Mexico" will feature the work of 12 artists from south of the border.

In actuality, federal agencies have not yet chosen a preferred route. Moreover, the U.S. Fish & Wildlife Service recommended moving the road, and the California Parks Commission and Native American Heritage Commission have filed lawsuits to stop the project.

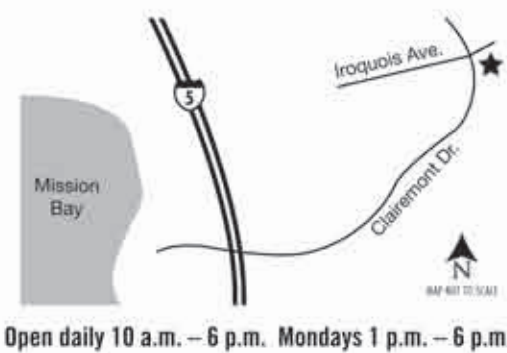

The NFL season started with a bang on Sunday.

There were upsets, injuries and outstanding debuts and performances. Carolina snatched victory away from the San Diego Chargers in the closing seconds and the Chicago Bears marched into Indianapolis and ruined the debut of the Colts' new stadium.

The balance of power in the AFC East and the NFL may have changed with the season-ending knee injury to New England Patriots quarterback Tom Brady. Meanwhile, Brett Favre led the New York Jets to victory in his first game with the team while the guy who took his job in Green Bay, Aaron Rodgers, also shined in his NFL debut.

And former Chargers running back Michael Turner rushed for an Atlanta Falcons team record in a win over Detroit.

Chargers collapse: Preseason dreams usually look better for most teams than reality. The San Diego Chargers found that out on Sunday when they suffered a heartbreaking 26-24 defeat at the hands of Jake Delhomme and the Carolina Panthers.

A preseason choice by many experts to reach the Super Bowl, the Chargers were left scratching their heads after Delhomme led the Panthers to victory with a 14-yard touchdown pass to Dante Rosario with no time left on the clock. Carolina sent five receivers

into the end zone while Delhomme pump-faked the Bolts defense.

Chargers quarterback Philip Rivers had just put his team up 24-19 on a five-yard pass to Vincent Jackson with 2:27 to play.

"We watched film on them and know what they would do, but they also did a lot of things that we didn't expect," Chargers linebacker Shawne Merriman said.

It was only the Chargers' second home loss in their last 17 regular season games at Qualcomm Stadium. Now they travel to Denver, where at least they know what to expect.

Bears upend Colts: Rookie Matt Forte ran for 123 yards, including a 50-yard TD run, and the Chicago Bears defense shut down a rusty Peyton Manning and his Indianapolis offense in a stunning 29-13 win.

Brady out for season: Patriots quarterback Tom Brady is out for the season with what appears to be a torn ACL in his left knee. He suffered the injury in Sunday's game at Kansas City when Chiefs safety Bernard Pollard hit him in the lower leg. Pollard had been blocked by Sammy Morris beforehand. Matt Cassel, who hasn't started a game since high school, takes over at quarterback for the Patriots.

Favre, Rodgers off to good starts: Former Green Bay quarterback Brett Favre and new Packers QB Aaron Rodgers kept their fans

happy in Week 1. Favre, now with the Jets, went 15-for-22 for 194 yards, two TDs and no interceptions in a 20-14 win over Miami. Rodgers was 18-for-22 for 178 yards, a TD and no picks in a 24-19 win over Minnesota.

Turner lifts Falcons: Former Charger running back Michael Turner made the most of his debut with Atlanta, setting a team record by rushing for 220 yards in a 34-21 victory over Detroit. Turner ran for two scores, including a 66-yard run.

Panthers claw past the Bolts 26-24 in the final seconds

Losses come in all shapes and sizes. Last Sunday's last-second setback for the San Diego Chargers at home was big and painful.

Nursing a 24-19 lead on the game's final play with :02 remaining, Chargers players and fans thought this one was in the bag. Carolina Panthers QB Jake Delhomme had the challenging task of finding the end zone or taking the long flight back to Charlotte at 0-1. Guess what?

Delhomme and tight end Dante Rosario connected on a 14-yard pass in the back of the end zone as time expired, sending the Panthers into a wild frenzy, while Chargers players, fans and coaches looked on in amazement.

Delhomme, who watched much of last season from the sidelines with an elbow injury, calmly marched the Panthers down the field after San Diego had taken the lead on a 5-yard TD pass from Philip Rivers to Vincent Jackson with just over two minutes remaining.

According to Delhomme, who passed for 247 yards on the day, the game's final play seemed to take forever.

"I'm just standing there," Delhomme said, "and it was like it was going in slow motion, just looking, looking, looking. Dante and I just caught eyes."

What the Chargers caught was a 0-1 start to a season many expect could end in Tampa next February for the Super Bowl.

San Diego, which came in as a 9-point favorite, was behind 19-10 in the fourth quarter before rallying for a pair of touchdowns, but the rally died on the field with Delhomme's heroics.

"I don't know if it's a wake-up call," San Diego running back LaDainian Tomlinson said. "It is what it is. There's no guarantees that you're just going to blow peo-

ple out or win all these games. They're hard-fought games." Yes, it was a hard-fought win, but for the Panthers, not the Chargers.

FIFTH QUARTER: Rivers finished with three TD passes on the day, while Tomlinson was held under 100 yards (97 yards) rushing. San Diego visits AFC West rival Denver this Sunday for a 1:15 p.m. start. The Broncos opened the season Monday evening with a 41-14 rout of Oakland.

Bucs break in Eagles' new field with 40-7 win

The Mission Bay Buccaneers sailed their football crew to El Cajon Friday, Sept. 5, where they took on the largest high school in East County in their first game of the season. City, county and school district officials were present to celebrate the first game on a bright new artificial turf playing field at Granite Hills High School.

The Buccaneers christened the new field well with a 40-7 cruise over the Eagles.

the Eagles put together their lone scoring drive capped with a 13-yard TD pass.

Late in the half the Bucs intercepted an Eagle pass at midfield. With 40 seconds left, Mission Bay capitalized and scored on a 13-yard pass from Allen to Anthony Alvarez.

It was 20-7 Bucs at the half.

Midway through the third quarter, a huge pass from Allen to wide receiver Herring got the Bucs 50 yards up field. The big play set up a 9-yard TD pass to Baxter over the right side.

Late in the third quarter, desperate pass plays by the Eagles emerged and the Bucs took advantage. Linebacker Austin Quintero snagged a Granite Hills pass and returned it 31 yards untouched to the end zone. The extra point was blocked — showing the Eagles had not given up.

Just 37 seconds into the fourth quarter the Bucs completed one more drive when Allen saw his receivers covered and banged his way 12 yards into the end zone for the final TD.

The Bucs put in the second

string for the rest of the game and coasted away with the comfortable win.

"The defense was beautiful," Matson said. "The offense did a great job adjusting under pressure — Granite Hills employs a tough defense."

Quarterback Allen received the "You Rock" award from the coaches for the game's best performance, presented by the cheer-squad, for his four TD passes and solo touchdown run.

The Bucs head off to Riverside County Friday, Sept. 12, for a game at Paloma Valley High near Perris. They return to host Bonita Vista high Sept 19 at 3 p.m.

Granite Hills was a Division I school while Bonita Vista is Division II — Mission Bay is Division IV in football.

"We have a hard schedule, and want it that way, so we will be prepared down the road when it counts," Matson added.

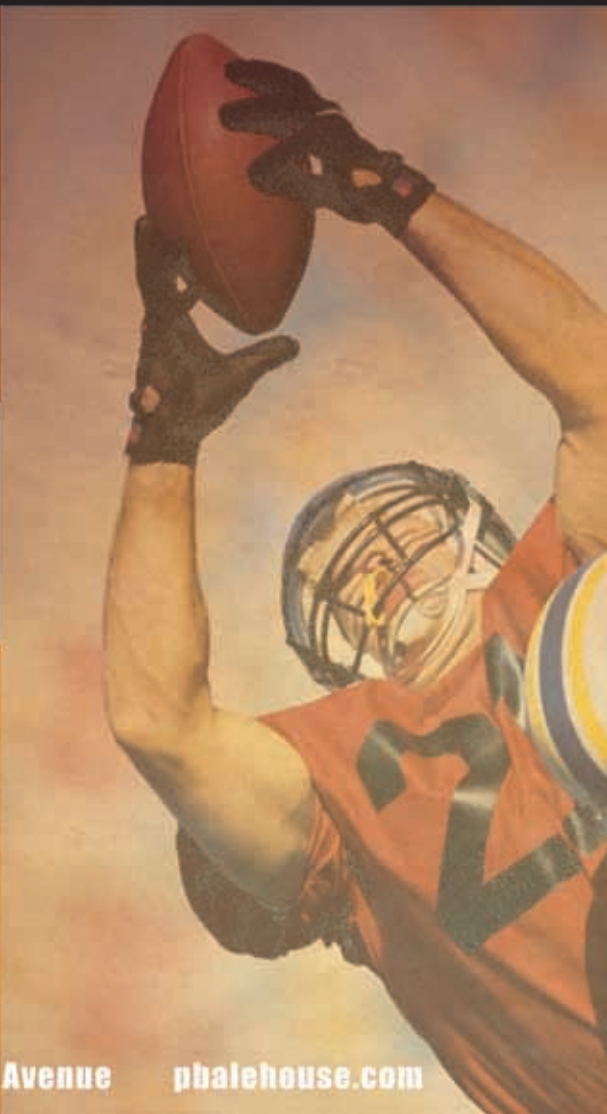

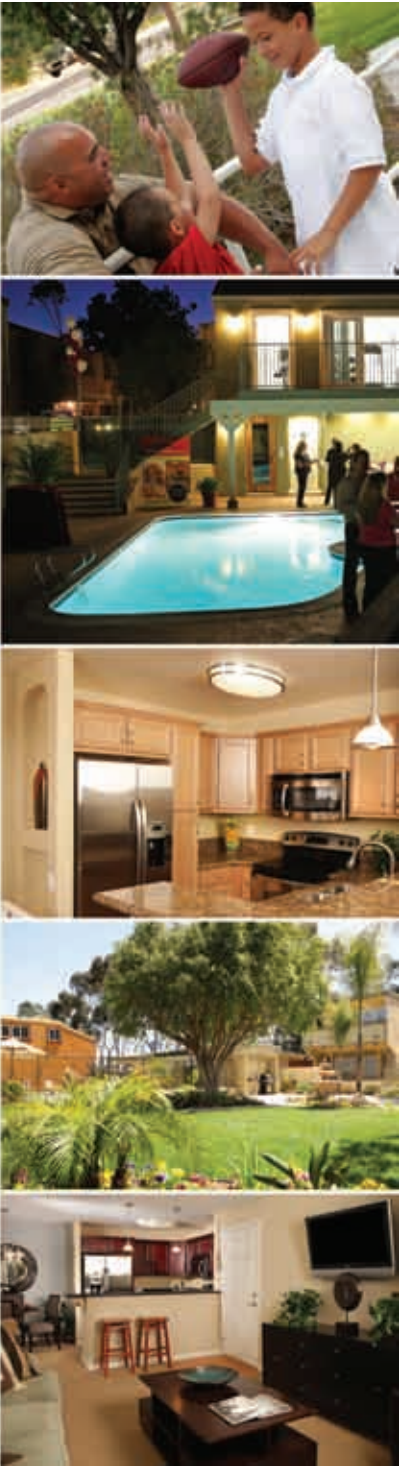

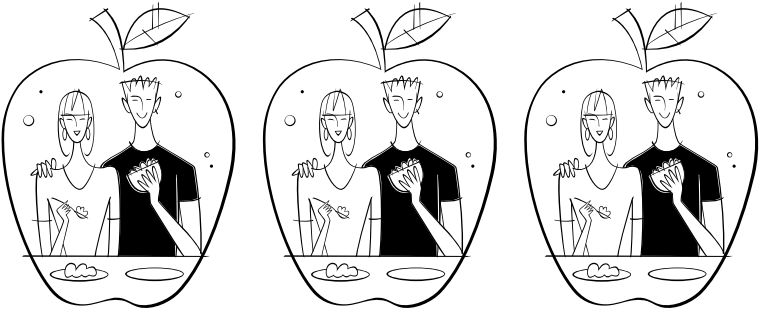

- 1¼ cups xylitol or cane sugar (available from People’s Bulk Dept.)
- ½ tsp. baking powder
- ½ tsp. salt
- 1 cup butter (2 sticks)
- 2 egg yolks
- 4–5 cups sliced apples
- 1½ tsp. cinnamon

Preheat oven to 350°. In your favorite mixing bowl, combine 2 cups flour, ½ cup xylitol, baking powder and salt. Cut in butter until mixture is crumbly. Stir in egg yolks. Press ½ of mixture into a lightly oiled 9 x 13-inch pan. In another mixing bowl, combine apples, remaining flour, xylitol, and cinnamon, then spoon apple mixture over crust in pan. Sprinkle remaining crumb mixture over apples, then bake for 45–50 minutes. Let cool before drizzling icing on top. Cut into 24 bars.

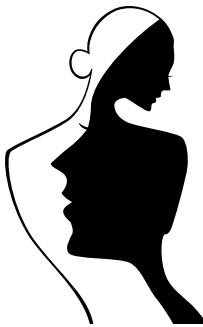

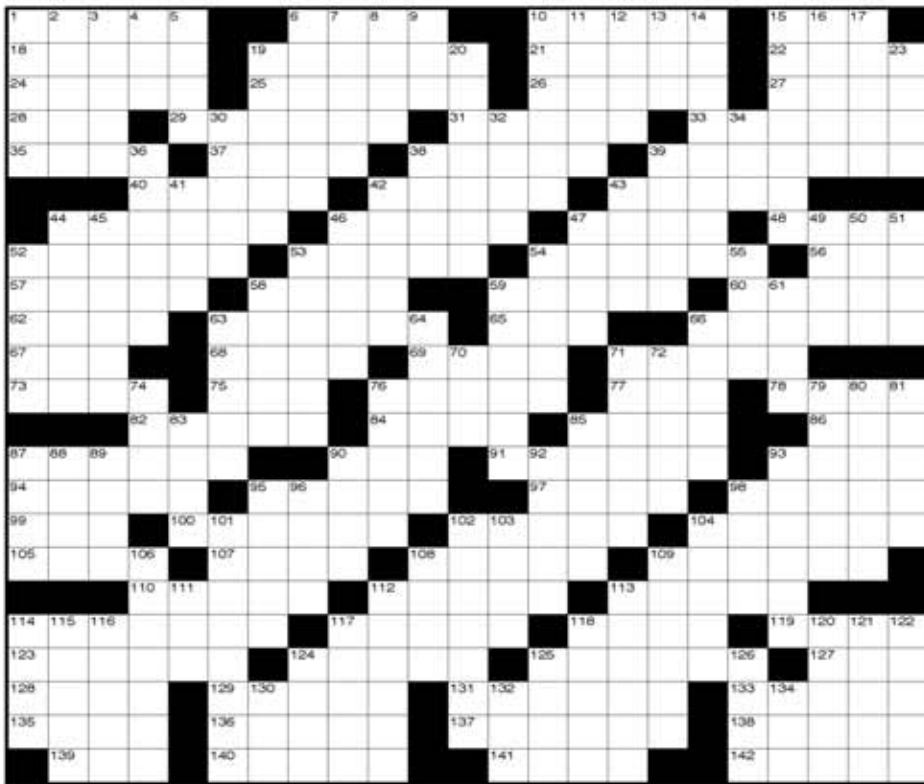
