New pavilion at Scripps Park plagued by design flaws

With complaints ranging from drainage problems to lack of privacy and foul odors, residents are taking a mostly wait-and-see attitude toward how repairs go with La Jolla Cove's new 1,500-square-foot, \$5 million shower and restroom pavilion.

"I am aware of and have been working with the director of the City's Engineering and Capital Projects Department and the mayor's office to swiftly rectify the privacy and water-runoff issues at Scripps Park pavilion," said District 1 Councilmember Joe LaCava, who represents La Jolla.

In March 2017, La Jolla Parks & Beaches, Inc, a civic group making land-use recommendations to the City on coastal parks, overwhelmingly approved updated plans for the pavilion-comfort station at Scripps Park.

The La Jolla Cove Pavilion was a long-term project to replace outdated and deteriorating restroom-shower facilities with an attractive, sustainable pavilion honoring the beauty of the Cove and Scripps Park.

Of the newly completed pavilion, Bob Evans, president of La Jolla Parks & Beaches said once construction fences came down in late January on the project, "that we could immediately see a number of issues that should have been addressed or cleared early on in the project phase."

According to Evans, overlooked facility flaws include:

- Sight-line straight from the sidewalk and street and park into the women's and men's change rooms. Our latest report is the City says at least another couple of months until new 'privacy partitions' can be installed. Meanwhile, local swimmers installed a couple of \$10 shower curtains, but they get torn down.
- The outdoor shower drains function poorly and seems to easily clog up, and water runs onto the new lawn causing a couple of new muddy swamp areas.
- Many areas of the new landscaping are poorly thought out to support high foot traffic and are now trampled or dying.
- The large front lawn is quite yellowed and looks half-dead already. Lawns have not thrived and have died in previous attempts. But we hope this install can be successful.
- There's going to be a fix-it list of items with any new project like this, and the City has addressed many. The list includes functioning door locks, stocked with more toilet paper, adjusting water pressure, and improving the view corridor in the park by moving large obstructing control panels.

Spring break kicks off busy beach season; lifeguards offer safety tips

Bonfires legal in designated concrete rings; alcohol illegal on beaches; learn the stingray shuffle

San Diego Fire-Rescue Department Lifeguard Division and San Diego Police held a joint press conference this month outside lifeguard headquarters to offer beach-and-bay safety tips for spring break.

"The weather's getting warmer, the beaches are beautiful as always, and with COVID restrictions lifted we're expecting a lot more people to come out," said SDPD Capt. Scott Wahl of Northern Division. "This is just the beginning of the spring and summer season, spring break is the kick-off. We will have additional police officers out in all the beach areas. We want to make sure it's safe for everybody, and we're going to do our part to make sure that it is."

Noting "laws are in place to help keep everybody safe," Wahl said police want to remind people that "there is still an alcohol ban on the beaches and no alcohol is allowed in

cups, cans, or glass."

Added Wahl about fire pits and boats: "Bonfires are only legal inside designated concrete bonfire rings. There are a lot of companies out there that want to sell bonfire equipment including bonfire rings: Those are illegal. We also see a lot of illegal boat rentals, jet skis, types of equipment that are illegal. One rule of thumb, if you're going to an actual brick-and-mortar store to rent a boat or out on a boat dock, that most likely is going to be a legal establishment."

With more than 40 miles of oceanfront and bay shoreline to patrol throughout the City, SDFD lifeguards help keep an average of 17 million visitors safe and conduct an estimated 7,000 rescues at local beaches each year. Additionally, lifeguards manage cliff, scuba, and swift water rescues, enforce boating safety regulations and respond to emergencies involving seafaring vessels and other watercraft.

"We staff up whenever crowds come and all we want is a safe 10 days of spring break," pointed out lifeguard chief James Gartland, offering these beach safety tips: "Always swim with a lifeguard. When you come to the beach, just check in with the lifeguard. All day long they are moving people in and out of rip currents, out of areas of hazard."

Gartland counseled people without strong ocean swimming skills to wear a Coast Guard-approved life jacket or stay waist-deep in the surf.

Regarding Mission Bay, Gartland said: "Safety out there is paramount. We're definitely out there making sure people (boaters) keep their speed at a proper level in proper areas. We also ask that, whatever you pack in to the beach, you pack out. Listen to what lifeguards are telling you to do. We are trained observers and we can see where the rip currents are. We know you're in danger before you're in danger."

Marine safety lifeguard Lt. Lonnie Stephens cautioned newcomers to surfing who are in town that the best way for them to learn how is to take courses from accredited, licensed local surf schools.

"Make sure you're engaging in business with a permitted concessionaire that's been vetted through the City," Stephens said adding those taking surfing lessons should ask a prospective surf company about their instructor's certifications, and make sure they have their business permit.

Stephens reiterated that it's very important to "always swim near a lifeguard in a guarded area. When you're not in a guarded area, lifeguards cannot observe you and prevent any of the hazards you might be in, such as rip currents."

Stephens also suggested that water users do the "stingray shuffle," moving their feet along the shore rather than stepping, in order to avoid getting painfully stung.

"Our first priority is that everyone is educated and understands what the rules are," concluded SDPD's Wahl. "We want to make sure that people are doing their part to stay safe."

UPDATE – PB wellness clinic, City working on compromise

Progress is being made on crafting a compromise solution for a Pacific Beach acupuncture and chiropractic clinic claiming an erroneous zoning citation by the City's Development Services Department could cost them tens of thousands of dollars in extra permit fees and potentially shut them down.

"The mayor got wind of the situation and assigned Kohta Zaiser, who has been amazing working with code enforcement and development services," said Larry Michel, business manager for

Source Empowered Wellness and Habstritt Chiropractic at 4666 Cass St. "He knows the routine and he is about finding solutions that work for the department, as well as the consumer. I am sure that we would be sinking quickly, or possibly closed today if it was not for his support backed by Mayor Gloria."

Dr. Simone Ressler, the owner of the Cass Street holistic health clinic, noted COVID safety protocols halved their patient treatment space, causing them to expand their facility into an otherwise unusable garage space, which ultimately triggered the City's citation for alleged zoning violations.

Michel said there's been a recent attitude adjustment between the businesses he works for and the City. "The first thing that happened was people in the (City's) departments started to have real conversations with us, rather than just stating their positions," he said. "They were listening and wanting to resolve things. Instead of a battle, it now feels more like a collaboration."

"Instead of threatening fines and a hearing, there is a focus on getting quality results for us while still following the intentions of the City's municipal code. Now we are waiting for the details and

follow-up. Hopefully, we will be moving quickly to resolving the use, getting the new build properly permitted, and we will be back in full swing again."

The unresolved zoning and permitting issues at the 4666 Cass St. property date back to May 13, 2021. That was when the City issued a citation saying the property leased by Source Empowered Wellness and Habstritt Chiropractic was in violation of San Diego municipal codes, and that the following issues needed to be corrected: unpermitted operating medical, chiropractic, yoga, and massage businesses; converting off-street enclosed parking space into office space to include interior partitions and electrical; and reduction of off-street parking.

"Source Empowered Wellness and Habstritt Chiropractic were being told that their use is not allowed where they have been operating for the last six years," said Michel previously, arguing the tenants' use there "fits within the designated services listed, specifically, beauty and personal care services. The City's Code Enforcement Division is citing the proprietors of the businesses as operating medical, chiropractic, yoga, and massage. They do not do yoga, medical, or massage. They do acupuncture, which is not considered medical services or treatments."

City officially honors historic Windansea surf shack

It's official, La Jolla's Windansea surf shack is a historic part of San Diego.

The iconic 76-year-old shack was designated historic by the San Diego Historical Resources Board back in May 1998. Now, 24 years later, the City has created an official plaque for the beach structure, fashioned from eucalyptus tree trunks and palm fronds, which was unveiled at a March 20 ceremony.

It was a special occasion as Mayor Todd Gloria also officially designated Sunday, March 20 as "Surf Shack at Windansea Beach Day" in the City.

Melinda Merryweather, one of the founding members of Friends of Windansea, a group of La Jollans dedicated to preserving the area's natural environment, said the shack is emblematic of the community and surf culture.

"It's to remind people to honor the guys coming back from the war in 1946 who built it for shade and aloha (love and fellowship)," said Merryweather. "It honors the people who had the shack designated as historic, including Hanz Newman and myself, and all the people who've managed it over the years."

Added Merryweather: "It is absolutely one of the most important symbols for the surf culture in Southern California. It represents

surfing and surf history. We won a Jewel Award (for exemplary achievements in housing) for it, which is usually given only to historic houses. This is the first Jewel Award ever given to a building without walls, which is pretty impressive."

One of San Diego's oldest and most high-profile beach landmarks, the shack's palm-covered hut was first constructed in 1946 by Woody Ekstrom, Fred Kenyon, and Don Okey. The trio came up with the idea for the shack in 1946 when Okey's wife asked him to build some shade on the beach for their kids. They went to Scripps Hospital and cut down some eucalyptus trees to build it, thinking it could also become a local surf haven. It quickly became a hugely popular venue for social events for surfers up and down the coast.

Destroyed and rebuilt numerous times over the years, the shack earned its reputation as a party hangout for surfers back in the day, as evidenced by the formation, in local surf lore, of the "Mac Meda Destruction Company." Mac Meda was a party-loving underground society of surfers and locals known for its rowdiness and propensity for destruction (hence the name). The group was actually mentioned in "The Pump House Gang," Tom Wolfe's famous chronicle of teenage surfers who hung out at

Windansea Beach in La Jolla.

Wear and tear on the shack over time forced it to be moved away from the oncoming waves near shore. It ended up where it is today, back toward the rocks underneath the bluffs of Windansea beach.

In addition to surfing, site-seeing, and Instagram posing, Windansea is famed for its massive swells and shore-break waves. Without a 24-7 lifeguard presence and a very strong south-bound current, this beach is for strong swimmers only. The consistency of massive waves, fueled by a large drop-off in the sand not far from the beach's edge, makes

for an entertaining time at all hours of the day.

"Hanz (Newman, owner of famed Su Casa restaurant) and I worked to get the shack designated as historic, and it was at that point that it went down in a storm," said Merryweather. "The City could have come in and said, 'You can't rebuild it without a permit.' Luckily, Scott Peters (former District 1 City Council member), and Howard Wayne (former State Assembly member), came to our aid."

"It's a treasure, a gift. It's an honor to take care of it. People in our surf community consider it our church," Merryweather said.

“I really enjoy the open architecture,” said Evans about the pavilion, pointing out that a lot of thought went into the details of its design, such as the initial vision, materials, color, texture, and the facilities itself.

“The new pavilion should stand to serve for the next 50-plus years as a center point to Scripps Park and the Cove,” concluded Evans, noting the area receives “well over a million visitors a year and is the most photographed spot in San Diego.”

Added Evans: “Altogether, the new pavilion is extremely well-received, and was a long-time coming for the community and visitors. Our frustrations stem from the seemingly lack or shortage of community feedback during the construction phases, as to how the visitors and community actually use and experience the area. It is taking a long time for the City to attend to some of the issues like the open view into change rooms. And we hope that the high-traffic lawn and landscaping area will thrive and survive as the increase of summer visitors descend on the park.”

Other La Jollans weighed in on the new pavilion and its problems.

Phyllis Minick was mostly upbeat – and hopeful – that the project’s flaws can be rectified in a timely manner.

“The E.B Scripps Park Pavillion is a stunning addition to our La Jolla shoreline,” Minick said. “Like many, perhaps most, new constructions, it has some structural and supply problems. Most of them will certainly be addressed by the contractors and maintenance services. Leaks into the surrounding lawn have been destructive but can and will be repaired. Those of us who used the former facility experienced decay, leaks, filth, and an insufficient number of toilets (which were often clogged).

“In contrast, the present building reflects current architectural styling, and design work by highly respected professionals, as well as enlarged numbers of showers and stalls,” continued Minick. “So, in a community afflicted

with homelessness, overwhelmingly in need of road repairs, and desperate for new streetlights, let's give this new structure some time for upgrades.”

Community activist Melinda Merryweather feels the project’s design is too contemporary. She would have preferred something more in keeping with the look and feel of the community and its roots.

“It looks like a train or bus station in Chicago,” Merryweather said. “I wished its design would have looked more like Casa Manana (nearby retirement center) or the Green Dragon (historic La Jolla art colony). It would have been nice if it looked more nostalgic, more La Jolla.”

Long-time La Jolla coffee shop Pannikin may close

With lease negotiations apparently having broken down and an April 9 move-out deadline looming, a GoFundMe page has been created to help the Pannikin La Jolla find new digs.

"Save Pannikin La Jolla," proclaims a flyer distributed throughout La Jolla Village, about the iconic cafe and coffee shop at 7467 Girard Ave.

"Pannikin has served the community for more than 50 years," states the Pannikin flyer. "For many, both young and old, Pannikin provides a simple place to unplug and listen to the birds sing. A place all are welcome to study, enjoy nourishing food, and most importantly, slow down to connect with one another. Please consider donating to Pannikin La Jolla GoFundMe or share the link with friends and family."

As of March 29, \$35,505 from 197 donations had been raised on the Pannikin Go Fund Me page toward a \$75,000 fundraising goal.

"Pannikin, which has been in La Jolla since 1968, is losing its space," said James P. Rudolph,

author of the GoFundMe petition. "This news is devastating for all who love and cherish this institution. Our good friends and neighbors need help with many things, not the least of which is finding a new home."

"This fundraiser recognizes the shock of this sudden news and is meant to assist in the search for a new location," continues Rudolph's petition. "There is no obligation, of course. But please consider helping if you are so inclined. This cafe isn't just part of the community; it 'is' the community. If you feel similarly, please consider supporting this cause."

"I'm not in a space where I am doing any comments at the moment," said Amanda Morrow, a longtime Pannikin employee who purchased the establishment in 2007 and operates the coffee cafe along with partners Gloria Serna and Dan Grunow. "But as soon as that changes, I will happily reach out. I am manifesting a positive outcome."

Rudolph said now is the time to contribute toward saving this 54-year-old community hub. "The owners and operators of Pannikin and the holders of the lease are,

from all appearances, at an impasse," he said. "In other words, there's a real risk the lease will not be renewed."

Added Rudolph, "Staying put obviously is the preferred option, both for the operators and the public. But moving, though less attractive as an option, is also on the table."

Rudolph said he started the GoFundMe page for two reasons:

He's a longtime customer and supporter, and because it deserves to be saved.

"This is where people gather, converse and, most importantly, connect," he said. "La Jolla is a more vibrant community when family-owned businesses thrive. I'm hoping the money raised can assist the owners with any possible upfront costs associated with securing a new location."

Pannikin Coffee and Tea was founded by Bob Sinclair. The cafe originally opened in 1968 in the Green Dragon Colony cottages on Prospect Street before moving to its Girard location in 1971, where it has been ever since.

"So the vast majority of Pannikin's rich history has taken place where the store is now located," pointed out cafe supporter Rudolph. "This is why so many longtime La Jollans, reminiscing about the 'good old days' from high school or college, have been shocked and saddened by the news of Pannikin's imminent closure."

Noting there are other "fantastic coffee options" in town, Rudolph pointed out that Pannikin brings something unique and is, therefore, in a sense, irreplaceable.

"Pannikin is a uniquely eclectic 'coffee culture' whose purpose has always been to welcome people from all walks of life," Rudolph said. "This is something worth protecting."

Concluded Rudolph about the Pannikin fundraising drive: "The outpouring thus far has been overwhelmingly positive, and it demonstrates the cohesiveness of this community."

The fast-casual taqueria eventually spawned multiple outlets around San Diego, which are all now under different ownership.

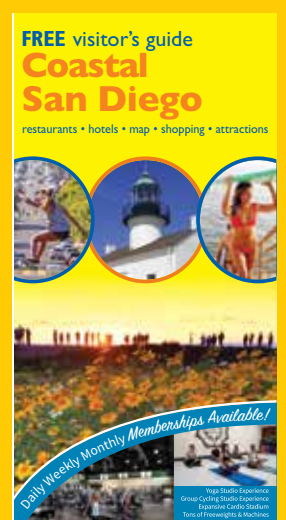

New cancer screening and diagnostic center opens

Exact Sciences Corp. recently opened a new cancer screening and diagnostic testing center in Torrey Pines.

"We are thrilled to expand Exact Sciences' presence in San Diego, a biotechnology hub with a deep talent pool," said Kevin Conroy, chairman/CEO of Exact Sciences, whose new facility is on N. Torrey Pines Road. "Our initial focus for this state-of-the-art research and development facility will be to develop next-generation cancer diagnostics to help patients and physicians make better treatment decisions and more effectively monitor disease recurrence. We plan to double the number of our San Diego-based employees."

Exact Sciences plans to use this additional laboratory space to advance early detection, minimal residual disease (MRD) cancer recurrence monitoring, therapy selection testing, and design of the company's proprietary blood collection tubes.

This effort includes the expansion of Exact Sciences' research and technology initiatives of cancer detection driven by biomarker discovery and advanced technology assessments, as well as the development of MRD tests capable of detecting residual disease from whole blood.

MRD tests are used for monitoring of circulating tumor DNA (ctDNA) to allow for earlier detection of recurrence as compared to digital imaging. Customized to identify a patient's specific tumor, MRD tests hold the potential to answer critical questions such as, "Did treatment remove all cancer?" and "Has cancer returned?"

Exact Sciences is best known for its noninvasive colorectal cancer screening test, Cologuard. Since its approval by the FDA in 2014, Cologuard has been used more than 7.5 million times to screen people for colorectal cancer.

Exact Sciences is working to bring similar advancements in technology and ease-of-use pioneered with Cologuard to other forms of cancer. Through growth and acquisitions, Exact Sciences

about the size of a grain of rice.

- **GEM ExTra** – A comprehensive genomic test capable of detecting damage in genes and providing a complete biological picture of certain refractory, rare, or aggressive cancers.

The GEM ExTra test provides physicians, academic medical centers, and biopharma researchers with vital interpreted information to help understand changes to a patient's genomic tumor profile and recommend therapeutic treatment plans.

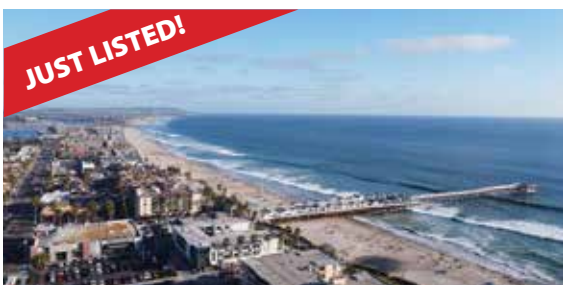

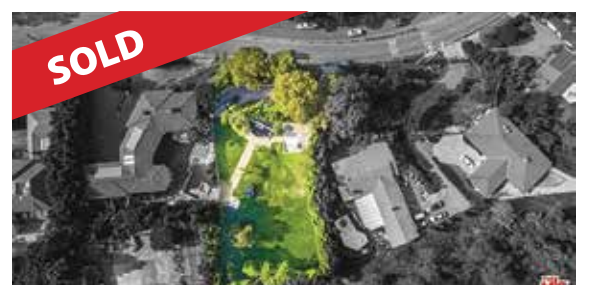

Doing it Better

A few days ago, a friend came to visit me with her new puppy, a 9-month old mini-Australian shepherd. After the puppy finished exploring my apartment and drank some water, he jumped in my lap and licked my face; I was smitten. All my nurturing instincts reawakened. I wanted, needed a dog. Of course, at 95, any dog would become an orphan within a very few short years; not fair for the dog. No, I am not getting one.

What is interesting that during the pandemic animal rescue centers saw a surge of demands for adoptions. People were isolated and needed something to take care of, needed companionship. During that time there was also an increase of plant sales, again the need to take care of something alive. This caring propensity shows itself early, as early as early as 4-6 months of age in children. Children hug their stuffed animal and cry when separated from it. In 1995, Donald Winnicott introduced the term "transitional object" describing the intense attachment children develop to an object. This attachment, part of a healthy ego development, is necessary to differentiate self from others as well as an early phase of independence from parents. The child is learning to sooth him or herself by gaining emotional support from the stuffed animal. The toy industry recognizes this and provides clothes and furniture for dolls fulfilling the child's need to care for an inanimate object, pretending it's real. Stroking the soft fur, holding a stuffed animal close, and cuddling it can reduce the stress coming from facing an unfamiliar situation or an unfamiliar care taker. The sense of security provided by the stuffed animal cannot only soothe a child, but can give the child courage to face new situations.

Most people have personal possessions that are treasured and serve as extensions of oneself. These cherished possessions may be connected to memories of important events or have belonged to a well-loved person. This is why it is often hard for people to move from a familiar home to a smaller apartment or retirement community. This move entails loss of objects too large to take or too cumbersome to keep.

Some people are able to easily discard some no longer used objects while others hold on to a variety of items that have no longer real use in their lives, only the memories attached to them.

Extreme object attachments may be a way to compensate for a lack of inter-personal attachments, or may be a symptom of a hoarding disorder. The diagnosis of hoarding disorder is based on the rating of intensity of emotions when imagining the loss of the object. In addition, the identity of the horded object may be significant. Holding on to years of old newspapers or discarded containers is different from holding on to a collection of travel postcards or ceramic figurines. As people age and experience physical, emotional, and cognitive changes, the attachment to objects also shifts. For some it intensifies; for others it is the reverse, they care for nothing any more.

Some people hold on to lucky charms or something hand-made that may have reflected a labor of love. Retaining golf clubs or a tennis racket in old age may be a reminder of an active past life. It is also difficult for widows/widowers to discard objects worn by their deceased partner. I still have a teddy bear donning a Navy uniform reminding me of Herman serving in the Navy.

As people age, one factor in senility is the return to childhood including the need to hold on to a stuffed animal. Many caregivers have reported that giving their older patients a stuffed animal has increased calmness and reduced agitation and anxiety in these patients. There has been a positive impact in giving a robotic pet to dementia patients. The robotic pet can respond verbally to comments and questions. They bring comfort and lower stress in preventing loneliness. By allowing the seniors to interact with these robotic pets also reduces depression and improves socialization and communication.

It is interesting to note that the need to nurture, to care for something, the need for companionship does not lessen with age. Even in dementia the human propensity does not diminish. The results of this new field study provides innovative insights to help improve better mental health in our aging population.
