O.B. RESIDENTS SUING CITY TO KEEP TREES

Ocean Beach residents are trying to stop the removal of palm trees on Newport Avenue after the San Diego County Regional Airport Authority requested the City remove the trees due to safety concerns.

Airport Authority requests City remove trees from Newport Ave.

Ocean Beach neighbors are suing the City in an attempt to block the scheduled emergency removal of several Newport Avenue palm trees, arguing the trees are healthy and historic and not a threat to incoming aircraft as the San Diego County Regional Airport Authority claims.

City crews recently were out in the neighborhood at the intersection of Newport Avenue and Santa Barbara Street intending to remove a dozen or more palm trees as requested by the Airport Authority,

which claims the trees may impair the visibility of airplanes. But a host of protesting neighbors, spearheaded by Tracy Van De Walker, successfully blocked the immediate removal of all but one tree.

Enter attorney Marc Applbaum, who's taken up the residents' case. He filed a cease and desist order on Oct. 21 to bar the removal of palm trees. On Oct. 28, Applebaum filed a suit on behalf of John and Tracy Van De Walker in U.S. District Court.

"The City is attempting to slip under the radar of public scrutiny and to avoid environmental review... by


instructing the City forester to cut down, extract and/or destroy iconic and historic palm trees on Newport Avenue, Santa Barbara Street, and Newport to Venice Street," states the suit. "Property owners and taxpayers were never told about the plan to remove the trees until they received a boilerplate letter from the San Diego Airport Authority on Oct. 16. Plaintiffs allege that contracts with the City to remove, extract and mutilate palms trees have created damage to the value of the use of the plaintiff's property. Such damage requires 'just compensation.'"

In answer to the Newport palm tree controversy, District 2 Councilmember and Council President Jennifer Campbell replied, "Our office is always saddened when trees need to be removed.

"The San Diego County Regional Airport Authority is responsible for operations at San Diego International Airport and is required by the Federal Aviation Administration and California Public Utilities Code Section 21659(a), to proactively mitigate and prevent future effects on

Online and in-person ceremonies to mark Veterans Day

Veterans Day on Nov. 11 is a federal holiday honoring military veterans who have served in the U.S. armed forces.

Originally known as Armistice Day, the observance commemorates the end of World War I, which ended at the 11th hour of the 11th day of the 11th month of 1918. That is when the armistice with Germany went into effect ending "the war to end all wars." The federal holiday was renamed Veterans Day in 1954.

Distinct from Memorial Day, a U.S. public holiday in May honoring those who've died in military service, Veterans Day honors all who've served, living and deceased, in all U.S. armed services.

This year, Nov. 11 falls on a Thursday. But most public observances of the federal holiday will either be before or after, the actual holiday.

Miramar National Cemetery Support Foundation, which includes Fort Rosecrans National Cemetery at 1800 Cabrillo Memorial Drive in Point Loma, is sponsoring a Veterans Day 2021 Video Program. That program will be posted at miramarcemetery.org beginning Tuesday, Nov. 9.

The foundation program's featured speaker will be Navy Lt.

Cmdr. Christopher Ludmer, a survivor of the 2001 terrorist attack on the Pentagon.

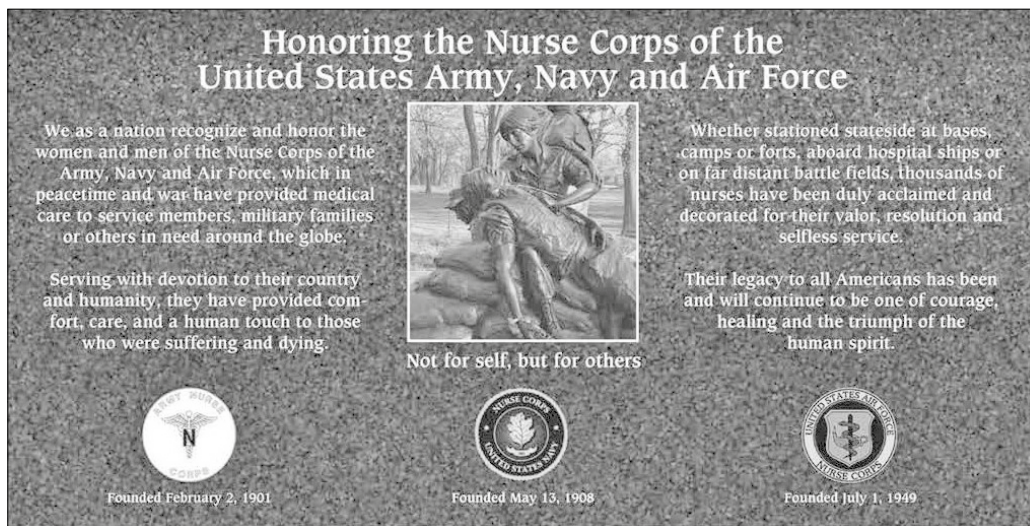
The guest speaker will be assistant fire chief John Wood of the San Diego Fire Department. He was the leader of the SDFD Search & Rescue Team that responded to the Twin Towers tragedy.

Fort Rosecrans became a national cemetery on Oct. 5, 1934. The decision to make the post cemetery part of the national system came, in part, due to changes in legislation that greatly increased the number of persons eligible for burial in a national cemetery.

The annual observance at Mt. Soledad National Veterans Memorial at 6905 La Jolla Scenic Drive South in La Jolla, will be held in-person and remotely on Saturday, Nov. 13 from noon to 1 p.m.

Keynote speaker for the event will be Rear Admiral Cynthia A. Kuehner, commander of Naval Medical Forces Support Command and senior nurse in the United States Navy.

She previously served with the

1st Force Service Support Group in Fallujah, Iraq, providing direct casualty care during the height of combat operations in support of Operation Iraqi Freedom and the first battle of Fallujah.

"From the hills at Gettysburg and the Meuse, to the jungles of Tarawa and Khe Sanh, to the arid lands of Fallujah and Kabul, the Nurse Corps has played a key role in caring for our armed service men and women. We honor them for their compassion, dedication, and service to our country," stated Phil Kendro, vice president of the Mt. Soledad Memorial Association.

Mt. Soledad veterans will also

commemorate the 100th anniversary of the Tomb of the Unknown Soldier.

This year's memorial plaque honors the Nurse Corps of the United States Army, Navy, and Air Force. Following the ceremony, the Nurse Corps plaque will join more than 5,200 other plaques enshrined on the walls surrounding the Mt. Soledad National Veterans Memorial. Honorees include U.S. presidents, 12 Medal of Honor recipients, generals, and celebrity veterans.

The event can be viewed at veteransdaylive.org. In addition to street parking, event parking is

available at Mt. Soledad Presbyterian Church at 6551 Soledad Mountain Road, and the French American School's two lots at 6550 Soledad Mountain Road. Complimentary Old Town Trolley shuttles run regularly the day of the event from parking areas. Parking at the memorial parking lot is available only to those with a reserved parking pass. is holding a series of free food distributions that celebrate local military families through Nov. 13. Feeding San Diego will celebrate local heroes at its Together Tour large-scale food distributions, some of which are still seeing up to 1,000 attendees drive-through.

Providing food assistance to the local military community is a year-round priority for the county's leading hunger-relief and food rescue nonprofit. Feeding San Diego is partnering with six of its community partners, all of whom will join the organization at its food distributions across the county.

PLHS sophomore Anastasia Birmingham and junior Caleb Rogart will be joining the planning group and participating in its environmental subcommittee.

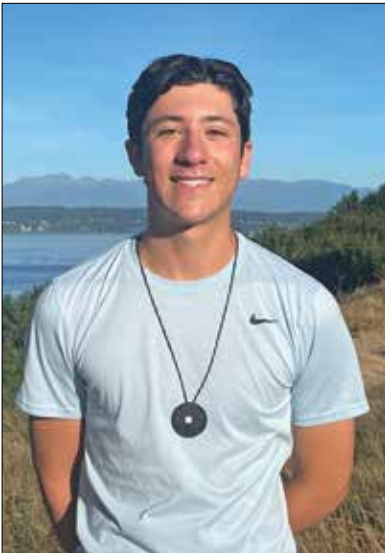
“The High School Student liaison position is a new pilot program that was recently approved and established by the PCPB to encourage high school students to get involved in their community

and to learn how it helps to make a change in our neighborhood,” said Mandy Havlik, who, along with Eva Schmitt, co-chairs the group’s environmental subcommittee. “We felt allowing high school students to get involved with the PCPB would encourage them to get involved in the civic process and allow them an opportunity to advocate for their community from their perspective.”

Added Havlik: “We need to hear the fresh ideas and perspectives from the youth in our community and we wanted to create a space to encourage this exchange of ideas. I strongly believe in democracy and want to

encourage our youth to get involved and show up for their communities. They will live with the outcomes of the current decisions being made by our political leaders.”

“I value the opportunity to be part of the subcommittee and its mission to strengthen our local community’s environment,” said Rogart about being a student liaison. “I’m interested in studying something environmental, though I’m not sure whether that’s going to be conservation science or environmental law. It’s always been my goal to help make the local, national, and global environments safe.”

“When I heard about this position, it tied together my interest in environmental sciences with civil action and community service,” said Birmingham about her subcommittee participation. “In the last decade, the issue of climate change has grown to incorporate all parts of society, and dealing with the challenge in front of us will require a strong desire for change. I anticipate that being in this position will give me relevant experiences with civil leadership and I will become more aware and

involved with my community.”

Rogart believes being on PCPB’s Environmental Subcommittee “will give me insight into the ways that local government works and how it functions. It will give me first-hand experience of how a voice on one committee, one group, can affect the whole community.”

Environmentalism is a top priority for Rogart. “You can’t survive without a functioning environment, not only with just living normally but also with food,” he said. “You can’t grow food if it’s too hot or too cold. And with the world’s population booming and going to reach 9 billion in the next couple of decades, the environment will play a huge part in how society functions.”

Birmingham said being a student liaison “is a chance to obtain relevant, valuable experience in civil leadership positions and is a role concerned with a topic I am interested in. This will introduce a new perspective on community and action to me and introduce new chances to get involved. Being a student liaison will help to develop the skills necessary to be successful later on.”

Birmingham expects to learn from her environmental committee mentors.

“They will provide certain projects and guidance,” she said. “Also, while observing and listening to meetings, board members will demonstrate (to me) the process involved in how an idea is vetted and either implemented or decided against, and their thoughts and conversations surrounding these decisions.”

“I am very impressed with the two candidates that were selected and we look forward to putting them to work here in the community,” said Havlik. “While they are not eligible to vote for board action items, they are going to be tasked with bringing an environmental policy recommendation to the board for their consideration. This recommendation will be created and crafted by the students along with the guidance and mentorship of Schmitt and me and the environmental subcommittee. We are very encouraged about this new opportunity and hope to continue this new tradition on the PCPB for years to come.”

airport operations by ensuring vegetation does not block or impair instrument or visual operations at the airport,” Campbell’s office said.

“The purpose of trimming or removing the identified palm trees is to ensure the safety of the community and the flying public as planes approach San Diego International Airport,” Campbell’s office said. “During inclement weather situations where visibility is impacted, the FAA re-routes aircraft to approach SAN from the west. The City of San Diego-owned palm trees located in the public right-of-way adjacent to the neighboring homes exceeds or will soon exceed acceptable elevations under federal standards, intruding into the airspace that surrounds the airport.

“We understand the impact that this has on the community, but unfortunately it is something that must be done to protect the traveling public and community.”

Cans4Books Community Initiative turns recyclables into reading material

Trisha Goolsby has started a movement to trade recyclables to help purchase children's books that would benefit communities including Point Loma and Pacific Beach.

Known as the Cans4Books Community Initiative, the drive was started by Goolsby who works with Stellar At-Home Educational Consultants and whose educational background focuses on early childhood/special education.

Goolsby's recyclables-for-books drive kicked off last December in the midst of the pandemic when she had some downtime during the lockdown.

"I decided for safety that I would collect unemployment from my home education business during the stay-at-home order," said Goolsby, who started a Facebook page for the Cans4Books Community Initiative, to promote the creation of a mechanism for raising funds from recyclables and converting that into a community benefit.

Trisha's notion was to "develop a platform to help support your neighborhood without asking for money or selling anything. I thought, 'Why not start collecting recyclables to raise money to buy children's books and bring that into the community?' So I created a fundraiser to try and collect 10,000 cans to raise money for

children's books."

Added Goolsby, "I wanted to bring the community together as a collective to recycle CRV bottles for money to bring educational resources into the hands of our neighborhood children."

On her Facebook page, Goolsby implores people to "Look out for those receptacles to dispose of your aluminum cans and plastic bottles. We shall see how much we collect and raise for children's books."

Noting her mission is to make Cans4Books "a nonprofit organization," Goolsby pointed out her initiative started with her running the show and even renting a truck to do her own pickups and deliveries. But her one-person operation has since morphed into a full-scale side business involving many other community-minded individuals.

"Our goal was to get the communities together in giving their streets a little TLC, as well as provide locations for CRV recyclable drop-off and free children's book pick-ups at our local small-owned businesses," said Goolsby, adding Cans4Books lends itself to social distancing and scheduled pick-ups. "That is where we have thrived," she said adding, "As Cans4Books community has grown, I wanted to get more businesses involved."

Noting there are "quite a bit of logistics and production that goes into recycling," Goolsby is now picking up recycling utilizing the help of community volunteers in several

neighborhoods. Volunteers are aiding Goolsby with turning recyclables into the CRV Recycling Center, which allows her to continue to run her education consulting business.

One of those volunteers is Kyle Stern.

"Kyle has been the final piece to my CRV trips, taking over our large loads of CRV recyclables accompanied with his son, turning it into a family affair to pick-up large scheduled donations," said Trisha noting that, before Kyle, "It would usually take me a few days finding a friend that would let me borrow their big vehicle."

Trisha added she has a mascot for her initiative, a stuffed monkey named Rupert, that she said has become "the face for Cans4Books that children love."

Cans4Books is now spreading throughout coastal communities

and gaining wide support, like the military housing community in Liberty Station in Point Loma, which has begun pitching in for the cause. The initiative also recently secured the cooperation of Pacific Beach Woman's Club,

Point Loma woman turning 100 with family celebration

Faith and family have always been the two pillars supporting Point Loma resident Ruby Lee Lewis Bigelow, who is rapidly approaching her 100th birthday on Jan. 5, 2022. That milestone event will be celebrated by Bigelow and her kin at Bali Hai Restaurant on Shelter Island on Jan. 7.

Asked her secret to longevity, Bigelow, who was born in Maysville, Okla., 20 miles from Oklahoma City nearly a century ago, replied: "I don't know if I have a secret. But I was brought up in a Christian home, and I was taught to try and always do the right thing."

Discussing growing up during the Great Depression, Bigelow recalled: "We didn't have a whole lot. But I don't remember ever going hungry. We always had food on the table."

Comparing today with yesterday Ruby noted: "The difference between then and now is so much technology that we have now. It's gotten a whole lot better. And that's good because we didn't know that we didn't have it then. We just did the best we could with what we had."

Bigelow was the fourth of five girls among six siblings. She, however, unlike some her age, is not old fashioned or bashful about using today's modern amenities, like the computer. "She uses a tablet and her iPhone," said daughter Patricia McAdow, who sat in on the interview with her mom in their comfy Sunset Cliffs home.

If there's a secret at all to her longevity, Bigelow said it lies with "keeping busy, staying positive. I

do crafts. I quilt, knit, and crochet. I work crossword puzzles."

"Every morning, crossword puzzles," agreed McAdow, about her mom's daily routine to stay mentally fit.

There's another key to Bigelow's longevity, said McAdow. "Mom is nice to everybody," she noted.

Becoming a centenarian is truly rare but is an increasingly reachable milestone. Thanks to improved medicine, better diet, and healthier living, humans' longevity has gradually increased over time. Today, roughly one person in every 6,000 reaches their 100th birthday – 0.0173 percent. Fifty years ago, only one person in every 67,000 reached the century mark.

Bigelow loves living near the ocean in Sunset Cliffs. "I sit out there and watch the sunset every night," she noted.

She said the Bigelow household's favorite activities were "mostly centered around our home church, Kentucky Avenue Baptist Church. There were parties, skating parties, playing until dark with neighborhood kids. We lived through

the Dust Bowl and the Great Depression in Oklahoma before I married my husband Earl and we moved to California in 1947."

Of her career, Bigelow noted: "As an adult I did secretarial work in the aerospace industry and later in the medical field. Since my husband was a minister for 85 years, I helped him in the music of our churches by singing, choir directing, teaching, organizing children's choirs, etc. We also shared a fishing ministry and held fish fries for those in need throughout San Diego."

Added Bigelow: "My husband Earl and I were honored by receiving the California Heritage award, the highest honor one can receive. This was awarded for many years of service, which included pastoring, music leadership, and serving on various state boards and committees."

McAdow said Bigelow is a big sports fan and she roots for the Padres in baseball and watches football religiously on TV during fall weekends.

Of she and her husband Earl's four daughters Bigelow noted: "Since his passing in 2015, all my girls have stayed very close to me. They are the love of my life."

Asked what life's greatest lessons are, Bigelow answered: "That we are all God's children. I am a Southern Baptist, but I do not believe that we will be the only ones in heaven."

Concerning what advice she'd give to others seeking to live a long and fulfilling life, Ruby's reply was simple, direct, and time-honored. "Treat everybody like you want to be treated yourself," she concluded.

Ocean Beach native dances to 100th birthday

Eileen Finley McCarthy, born and raised in Ocean Beach, celebrated her 100th birthday on Oct. 25 with all six of her children. She delighted her guests by singing a beautiful rendition of "Summertime," a song she sang on the birth of Summer, one of her 16 grandchildren.

McCarthy was well-known in the 1930s and '40s in the San Diego arts community. She was a principal dancer in the Starlight Ballet Company under Marguerite Ellicott, an early precursor to the San Diego Ballet. She supported her dance training by singing and acting in the popular radio show, "The Children's Hour," hosted by a young Art Linkletter.

McCarthy traveled to Los Angeles to study with Agnes DeMille, where she was discovered by a Russian choreographer, Theodore Kosloff. Kosloff was impressed by her ability to perform intricate jumps on pointe. Kosloff choreographed several dances for McCarthy inviting Cecil DeMille to see her perform. DeMille was taken with her dancing and her beauty. He auditioned McCarthy for the starring role in his planned movie, "The Ballerina."

But like a romance novel, her beau, James McCarthy, followed Eileen to Hollywood. He proposed to her on the stairway of the artist residence that DeMille provided for her. She was deeply in love, although torn by the decision to leave her fairy tale dance career, returned to San Diego to marry Jim McCarthy. They continued to share an amazing love, raising their six children until Jim's death in 1964.

In later life, McCarthy never lost her love for dance. She performed in theater productions at Laurence Welk's Retirement Community in



Escondido. She became an aerobics dance instructor in her 70s. She eagerly taught seniors at Welk's, 24 Hour Fitness, and various retirement communities around San Diego until she was nearly 90.

McCarthy can still often be spotted walking the OB Pier, and Balboa Park near her beloved

Old Globe Theater. She frequently will lose her walker to demonstrate various dance steps such as "The Clog" and "Two Step" to anyone interested.

Ever the star of the show.

DTSC has determined that the chemical poses an imminent and substantial endangerment to human health and the environment if not properly managed. Therefore, an emergency permit should be issued. This Emergency Permit is effective from August 24, 2021 through October 25, 2021. The Emergency Permit includes measures to minimize any adverse impact to the community and the environment.

Final regular season win puts Pointers into playoffs

With a decisive win in their final regular season game, Point Loma's Pointers earned a spot in CIF Div. II playoffs begin on Nov. 5.

In an Eastern League game at home last week, the Pointers fell behind 3-0 after an early field goal by Christian High but by the time the Patriots scored again the Pointers held a commanding 28-3 lead with only 5:36 to play in the game. Anthony Young added an exclamation point to the Pointer win when he scored on a 12-yard run with 17 seconds left to give his team a final 35-9 margin.

With the win, the Pointers finish their first regular season under head coach Joel Allen with a 4-5 mark, 2-2 in league play, and snatch a coveted ticket to postseason play. As the No. 12 and final seed in their division, the Pointers will hit the road for a meeting with Valley Center High, a member of the Valley League where they finished in third place (3-2) and 5-5 overall. The kickoff is at 7 p.m.

"You're always trying to give kids the experience that high school football is fun," head coach Joel Allen said after watching his team defeat Christian. "A lot of these kids had their first varsity win this year and now I hope they get their first playoff win. The seniors deserve another opportunity and the young guys need the

experience. If we play like the team we coached tonight I don't think we'll be a football team a lot of teams want to play"

Local coaches chose to use CIF Power Rankings this year as the basis for playoff consideration, discarding the previously used MaxPreps ratings. The Pointers are rated 12th in the CIF system and Valley Center No. 5. Ironically, in the MaxPreps system the Pointers are listed ninth and the Jaguars 11th, so it appears the teams are evenly matched.

Statistics support that prediction. Offensively the Pointers outgained the Jaguars in rushing yards by nearly 100 yards per game while the teams had nearly identical passing yardage. The

Pointers averaged 28 points per game, the Jaguars 24.

Meanwhile, all of the Pointers' offense against Christian came on the ground. Running backs totaled 55 carries for 332 yards, an impressive average of six yards per carry.

Leading the group was Chase Lawry (26 carries for 180 yards). Noah Turbeville (16 for 93), Anthony Young (6 for 31), Aaron Lee (6 for 18), and Cameron Lucas (1 for 10).

Lawry and Turbeville each scored twice before Young's final touchdown. Lee converted all five PAT's.

The Pointers did not get on the board until a Turbeville run just 56.4 seconds before the first quarter's end. Next, the team got a break when a completed Patriot pass was fumbled and an alert Lucas scooped it up, returning it 16 yards to the Patriot 15. Turbeville once again blasted

into the end zone from five yards out for a 14-3 lead 5:17 before halftime.

When the Pointers regained possession with just two minutes left before the break, they drove for their third touchdown, Lawry pounding the ball in from five yards out with just 19.7 seconds on the scoreboard giving the Pointers a 21-3 margin.

After a scoreless third quarter, Lawry added his second score from one foot out to build the Pointer lead to 28-9 with 7:50 remaining.

Defensively Lawry had a sack, Emmett Jacobson caused a fumble, and Nate Terzoli had a late interception.

Leading tacklers were Rocket Robinson (7), Cayden Nantkes, Jacobson, and Lawry (six each).

"We played with a lot of emotion tonight," Allen said. "We've had an up and down season in terms of quality of play. We had some
