NAVWAR REDEVELOPMENT

The so-called "San Diego Grand Central," a proposal to pursue a regional transit station and airport connection as part of a redevelopment of the U.S. Navy's NAVWAR campus in Old Town, has reportedly been abandoned. Instead, regional leaders have decided on a two-part plan that would provide a rail transit connection to the airport in the short-term, and allow them to pursue a large-scale hub for the region's transit system. That effort is envisioned for the current City Hall complex and a handful of nearby blocks owned by public agencies.

"We're working on a common vision for the region by recognizing the opportunity to advance a trolley to the airport on a concept that is, in regional transit terms, on the fast track, say within the next 10 years

or so," said Mayor Todd Gloria, who is also vice chair of SANDAG, the region's transportation planning agency. The Navy plans to continue to redevelop the obsolete NAVWAR facility, but without SANDAG as a formal partner. The Navy prefers a mixed-use project that would include a new NAVWAR headquarters built around a new transit station.

CREEK TO BAY CLEANUP

I Love A Clean San Diego is set to hold the 20th anniversary Creek to Bay Cleanup on Saturday, April 23 from 9 a.m. to noon, the day after Earth Day. The event has become the region's largest one-day environmental volunteer effort honoring Earth Day. This year, Creek to Bay returns to in-person, group volunteering at nearly 75 sites around the county. Organizers expect over 5,000 volunteers of all ages to participate. Free online registration available at Creektobay.org. In 2021, volunteers reported removing nearly 30,000 pounds of litter from streets, parks, canyons and beaches. On event day, all volunteers will see cleanup totals displayed, in live time, on the Volunteer Impact Map at Creektobay.org.

"Bringing people together as environmental volunteers is core to what we do at I Love A Clean San Diego and creates the greatest impact at the Creek to Bay Cleanup," said Lauren Short, the event's director of community engagement. "We will have designated sites with site captains for

people who want the group experience and will provide the close-to-home option for those who wish to volunteer that way."

Pickleball players want more courts, tennis players don't love it

On April 5, Pickleball and tennis enthusiasts crossed rackets in a turf battle over a proposal to convert Robb Field tennis courts in Ocean Beach into 36 pickleball courts.

Both sides, about equally represented, packed Santa Clara Recreation Center volleying back-and-forth during Mission Bay Park Committee's monthly meeting. The committee heard both sides out but took no immediate action.

Pickleball supporters contended there is a lack of places to play locally for the rapidly growing sport. Peninsula Tennis Club players, who use Robb Field courts, turned out in large numbers with colorful signs and costumes to argue it is unfair, and inadvisable, to remove existing tennis court space.

Pickleball proponent Stefan Boyland argued Robb Field tennis courts are underutilized and in poor condition, contending tennis players there could be accommodated at nearby Barnes Tennis Center.

"It's a sport we love and hope to bring to Robb Field," said

Boyland who, along with Mike Shinzaki, has been lobbying to develop more pickleball courts regionwide. "We advocate for local residents who want more courts in San Diego. We are happy to see tennis folks here because there is a lot of misinformation, and it's good for tennis players to hear our proposal directly from us."

"We have assessed over 50 candidates (pickleball court) locations and none of them have worked because they're either too small or there is no parking," said Shinzaki during a joint slideshow presentation with Boyland. "A location needs to be away from residences for light and noise permitting. Adding new cement is not a realistic solution. So we must share finite public land. The City asked us to prove local support: We have 4,000 local players on the petition. We have 11,000 letters of support."

Todd Sprague of Peninsula Tennis Club countered that the pickleball side's argument was flawed. He attacked their study of utilization of Robb Field's tennis courts, claiming statistics they used failed to address that tennis courts there are heavily

utilized more at certain times than others.

"Peninsula (Tennis Club) is in good standing under its use permit, and parks and recreation does not believe it (Robb Field) is a viable alternative for a pickleball facility," Sprague said. "Tennis is a growing sport. In San Diego, there are about five to six times more tennis players

than pickleball players. There's a great need now for more tennis courts."

Added Sprague: "Seventy percent of tennis is played on public facilities. So the idea of taking any public facilities out of circulation is a real problem for tennis players. This is not to say pickleball isn't growing. It's just to say tennis is growing and actually

services a whole lot more people. What we all recognize is that (tennis court) utilization has peaks and valleys. They (pickleball supporters) would like you to believe that's not the case. But it's true."

"Our view is that the public parks are meant for the benefit of the entire community," concluded Shinzaki after the April 5 meeting. "This isn't about which sport is better, but about efficient use of public park space. Right now, 37 combined tennis courts at [Robb Field] plus Barnes combined are hardly used (25% usage, on average). The City should require them to share space, or cede ground, allowing pickleball a chance to exist and grow."

During public comment, more than one person testified that they played both sports, adding the real issue wasn't pickleball versus tennis, but rather finding ways to accommodate both sports and encouraging more active recreation in general.

When asked what their next step would be, Boyland replied, "To get approval for re-purposing Robb Field tennis courts for pickleball, and to get a letter of recommendation so the City can consider this."

PLNU's baseball diamond named 'America's Most Scenic Ballpark'

Carroll B. Land Stadium on the Point Loma Nazarene University campus was recently named "America's Most Scenic Ballpark" by Major League Baseball.

PLNU was recently highlighted by MLB.com with a "Look inside America's most scenic ballpark" (mlb.com/news/). Nestled on the seaside cliffs of Point Loma, no other collegiate baseball park can match the picturesque views and comfortable setting of the school's oceanside field of dreams.

Coaches, players, and fans marvel at the beautiful park and its magnificent surroundings. The immaculate green grass of the diamond is framed by the blue sky and sea. The park's cozy dimensions are offset by the prevailing winds blowing in off the ocean.

The ball field has helped to recruit a strong team to Point Loma, which boasts an impressive 27-3 record, and is ranked No. 3 in the nation in the latest NCAA Division II poll.

"I think the field is the best it has been, and it's the best team we've had," said Steve Riddle, PLNU assistant athletics director. "Our goal is to make sure that anytime recruits come, the field is up to par. If they get to play on it, in a tournament or a prospect camp, we try to make sure that it is game-ready."

It was sportswriter Kevin Kernan of the San Diego Union-Tribune who, charmed by PLNU's

baseball facility, originally christened it in a 1993 article as "America's Most Scenic Ballpark."

The university's ball field recently has undergone changes to enhance both the field and spectators' views. The university padded some of the outfield walls, but kept left-center and right-center field as chain-link fence (referred to as the "windows") so spectators can watch the baseball game – and the ocean – at the same time.

Though the ocean appears to be right on the other side of the outfield fence, it actually is a quarter-mile away. So any home runs leaving the field can be recovered without underwater gear.

One unique aspect of this ballpark is that although the stadium is small, it is difficult to get the ball up and out of the park. "We get an

on-shore breeze most days, so that makes the park play a lot bigger," said Riddle, who also manages the university's athletic facilities, in an MLB interview. "We used to have guys that would come in and say, 'Oh man, I'm gonna hit three home runs today.' But then there's always the smart guy on the team, and the smart guys say, 'Dude, the wind's blowing in. You're gonna hit nothing but popups.'"

In addition to the incredible views, the turf has also been meticulously cared for by a turf specialist who learned his craft from a Petco Park groundskeeper, making it one of the smoothest playing surfaces in college baseball.

Back in 1998, at the National Baseball Coaches Association's banquet at San Diego's Downtown Marriott, athletic director and

Before relocating to Point Loma in 1973, Pasadena College had no on-campus baseball field. The team played its home games at Arcadia Park, Victory Park, and Brookside Park in Arroyo Seco. So from 1961 to 1973, head coach Carroll Land carried out a college baseball program without a field.

After the college took over the present campus from Cal-Western-USIU, it inherited the Point Loma school's ballpark. While Land and the university were happy to have a field of their own, many improvements needed to be made.

The remainder of the '70s saw retaining walls installed along the left and right field lines, eliminating the numerous and annoying ground-rule doubles lost in the ice plant that grew within feet of the foul lines. The precarious steps that led to the dugouts, or "dug ups," were replaced by ramps and 270 sheets of plywood reinforced the dilapidated wooden fence. The facilities continued to improve dramatically when the six-foot-high "dug-ups" were replaced with field-level dugouts.

In the '80s, a concession stand and restrooms were built and the wooden fence was replaced with the present chain-link one. In the 1990s, the facility took on its most dramatic remodel. Thousands of yards of earth were removed and much-needed multiple batting cages and a simulated pitching zone were built.

The field continued to be refined over the years. A new scoreboard was added; seats that replaced the concrete benches were installed; a club-view seating box over the home dugout was built; the height of the protective backstop was doubled; the grassy festival seating area down the right-field line was quadrupled; a 2,800-foot observation deck was built on top of the new athletic training clinic, and a new batter's eye and announcing booth were installed.

Fittingly, in 1998, the park was named Carroll B. Land Stadium honoring the man who guided the program for 39 years. It was his dedication and hard work that transformed the park from a literal diamond in the rough into the gem it is today.

baseball coach Land, about to be inducted into the ABCA Hall of Fame, had no inkling he was about to receive another major honor. The picturesque field that's tucked into the southwest side of the Sea Lion campus had been named Carroll B. Land Field after the legendary coach and administrator.

"I thought I knew what I was going to say up here," said Land. "Now it seems I struggle to find

the words ... how to say thank you to my institution, out of love and gratitude for the opportunity to serve. This job has allowed me to become part of something far more important than being involved in a great sport. I've had the opportunity to influence and be part of the lives of young men. It's an incredible opportunity, but, more than that, a tremendous responsibility."

New Point Loma Tea owner steeped in tradition

Changing of the doily at Point Loma Tea in Liberty Station has a former customer replacing the owner who started the business.

Sherryann Stevenson, a native of Grenada in the Caribbean and retired military, recently took over for previous owner Cheryl Graf, who has sold the business and retired to Arizona. Over the years the pair found they shared the same passion. “My family always had tea in our house and we drank it on a daily basis,” said Graf, noting she worked in tea, in various capacities, for 20 years. Graf set up her own tea shop in Liberty Station in 2012.

“I grew up drinking tea in the morning, afternoons, and evenings, it was a staple,” concurred Stevenson. “It wasn’t uncommon for my mom to say, ‘Hey, go in the backyard and pick some mint leaves, lemongrass and ginger, cut that up, put it in a pot, and brew our tea.’ My love of tea started then as a little girl.”

Graf said the former Naval base

was fertile ground for a new business.

“I got in on the ground floor with a small shop in the Arts District and word got out (about her shop) as people were enjoying the Arts District and the food (public) market,” Graf said. “We just continued to grow for the last decade. So I ended my tea career on a high note.”

Tea is an aromatic beverage with a stimulating effect from caffeine, which is brewed from an evergreen shrub native to China and other East Asian countries. After water, it is the most widely consumed drink in the world. There are many different types of tea with vastly different profiles including bitter, sweet, nutty, floral, or grassy notes.

Tea drinking dates back to the third century A.D. and the Chinese Tang dynasty. It subsequently spread to other East Asian countries. Portuguese priests and merchants introduced it to Europe during the 16th century. During the 17th century, drinking tea became fashionable among the English, who started to plant tea on a large scale in India.

Stevenson traveled the world over

sampling teas. She then started doing her own tea tastings. “My original business was to sit and sip teas,” she said, adding she was trying to figure out what to do next after 26 years in the Navy.

Stevenson’s years-long friendship with Graf proved fortuitous.

“I told her I was seriously thinking of going into the tea business,” said Stevenson. “And she’s like, ‘I’m thinking about retiring.’ I said, ‘Well my retirement date is in November.’ And she said, ‘I’m thinking of retiring in November also.’ I’m looking for someone to take over my business.”

Graf was ready to hand over the reins of Point Loma Tea “to the right person to carry on their passion for good tea and service. Sherryann was a friend, a customer. And, it was her dream.”

Of Point Loma Tea, Graf said: “It was tough to walk away. I enjoyed it. It wasn’t work. It was a joy to go into the shop every day.”

Point Loma Tea has over 150 selections of teas. Stevenson intends to start having tea tasting workshops to educate the public. She also plans

to upgrade the website at pointloma-tea.com.

“I’m keeping the basic business model,” Stevenson said adding customers can order online and have products shipped directly to them. “We have our tea bar where you can have hot and cold teas,” she said adding, “We sell brewing mugs, teapots, sets, towels, cups, etc. And, we try to change the shop around according to the season.”

In May, Point Loma Tea will begin hosting small groups. “I’m also working with Liberty Station to see if we can host tea on the lawn,” added Stevenson.

Stevenson intends to carry on the tradition begun by Graf.

“The customers here are very friendly,” she noted. “Whenever they walk in the door they smile. That’s the kind of thing I want to continue, carry on that legacy.”

Broken Yolk — a delightful way to start the day

It seems like people want to go out and start resuming their “normal” lifestyle. Ibrahim, better known as “Al,” the owner

of Fairouz restaurant, is one such person. It is amazing to me to find out that he does not have a real knowledge of Mexican food and when you realize that he spends seven days a week in his

own restaurant, he doesn’t have much of an opportunity to sample other fares. We decided to go out for breakfast, and the Broken Yolk was my choice.

Overall, the menu has not changed much from the first time I went to the one in Pacific Beach. But one of my favorite pancakes – the ginger one – is no longer on the menu, and I suspect there are many other items that have been replaced with other options. It is also interesting to note that after each item the amount of calories is listed. That seemed to be a factor in Al’s choice.

But before we get to that, I want to tell you some of the items that are available on their very extensive menu: There are Healthy Styles, that have a fair choice of vegan and/or vegetarian items. There is the two-egg breakfast classic. Also offered are breakfast craves, breakfast skillet, omelets, and Benedicts, south of the border, griddle favorites, including

gluten-free items, French toast and crepes, and a wide variety of beverages. The lunch menu includes burgers, sandwiches, wraps, fresh salads, and soups.

Al decided that he wanted to try the Greek omelet. He mentioned that it only had 300 calories. It consisted of an egg-white omelet filled with spinach, tomatoes, feta cheese, and kalamata olives. It was listed as “vegetarian.” He was offered toast, hash brown or French fried potatoes, or fruit. He chose the toast and French fries. He said that it was delicious, and would order it again.

I ordered the huevos ranche-ro omelet, which was served on a grilled corn tortilla, with two eggs cooked over medium, home-made ranche-ro sauce, and served with Mexican rice and refried beans, with a dab of guacamole on the top. It stated that that

item was 650 calories. I elected to have only the rice instead of the beans. I also had my choice of flour or corn tortillas and chose corn.

The ranche-ro sauce was good – a little spicy. I gave a bite to Al so that he could see what the spice tasted like and he said it was wonderful.

Al ordered coffee with his meal, and the server kept refilling his cup so it never got cold. I ordered tea and was given the choice of green tea, black tea, chamomile, or orange and spice herbal tea. I chose the orange and spice tea and it was served on a plate with two tea bags, three honey packets, extra hot water, and a wedge of lemon.

Even though many years have passed since my first visit to the Broken Yolk, I am happy to say that the quality has not changed. I would go there again without hesitation. With as many items on the menu for all tastes and restrictions, it would be a place that would satisfy everyone. The service was good. The server was friendly. It was a delightful way to start out the day.

Point Loma Summer Concerts Series returns in July

Back live from a two-year COVID hiatus, the Point Loma Summer Concerts Series presented by Willis Allen Real Estate returns on consecutive Fridays this year from July 15 to Aug. 12.

Since 2001, Point Loma Summer Concerts, founded by Bridget Cantu Wear, wife of former City

Council member Byron Wear, has been bringing family-friendly concerts to Point Loma Park, 1049 Catalina Blvd.

The event offers free parking, with a free shuttle service, 5-8:30 p.m. on event nights, from the parking lot of All Souls' Episcopal Church, 1475 Catalina Blvd.

Up to 3,000 music fans are expected to take in performances from a wide variety of cover and

tribute bands, with opening sets on the Junior Stage performed by groups of local students.

"It's simply a free concert for the community," said concert chair Kerri DeRosier about the summer series, whose mission is also to support local school music education. She added the fundraising part "comes from our raffle ticket sales, and all the proceeds go to music education programs."

"We want real variety in our lineup," said Martha Phillips, former president of the event's board of directors. "Our audiences span a wide range of ages, from babies to senior citizens, so we look for bands that have wide appeal."

Of this year's concert series, DeRosier said: "Expenses for putting it on have gone way up, almost twice as much for security, and it's all related to wages going up."

DeRosier pointed out there are numerous workers that have to be paid to stage the Friday events, including those setting up and breaking down the stages, as well as those handling sound for the guest bands.

"We are not making money, we don't have any paid staff; we're all volunteers," noted DeRosier adding, "Because we're a nonprofit, we can't give to other nonprofits. So we have raffle proceeds paid for by the (concert) fans who come."

The concert chair said raffle proceeds have raised more than \$84,000 over the years to support the Peninsula cluster of schools. "We've given money to Point Loma High and Correia and Dana middle schools," DeRosier said. "We also have volunteers from other organizations in the community who help out such as MADCAPS, and Girl and Boy Scouts."

Getting sponsorships from pandemic-stressed businesses has also been challenging this year,

Jennings House Café's exhibit celebrates Point Loma history

Poultry farm, gun batteries, tuna packing, a couple of nomadic yacht clubs, and even a bite to eat: There's something for everyone at the Jennings House Café. Its walls are talking!

Café owner, Cathy Gallagher, has partnered with members of La Playa Trail Association (LPTA) in hosting a Point Loma photo exhibition. "It fits with the historic significance of this old house," Gallagher says.

It's your history that's being

"spoken," a narrative reaching far into Point Loma's past.

At about the time purveyor Alonzo Horton was developing his 960 acres in New Town San Diego, German-Jewish immigrant Louis Rose was initiating his Point Loma settlement known as Roseville. That was 1870-ish.

Yet these land developers were long preceded by native peoples such as the Kumeyaay. Along the bayside trail came Spanish priests and soldiers, fur trappers, Boston-China traders, Portuguese whalers and Chinese fishermen, U.S. Cavalry, American cowboys, and

others. All of them traversing La Playa Trail, a commercial path on the peninsula of La Punta de la Loma de San Diego, or Point Loma.

Pictorial highlights gracing the Café's walls include, for example, the history of the Jennings House itself. LPTA president Kitty McDaniel says, "This is one of the first homes built in Roseville in 1887 (date varies by accounts) and it is still standing, repurposed for leisure and safekeeping."

The homes of Frank and Fred Jennings and in-law George Crippen were landmarks, McDaniel notes. "People coming down La

Playa Trail would see a house with a family living it. Before that, there not much more than a dusty path with fishermen shacks."

In years to come, land parcel acquisitions, a wharf renovation, a poultry farm of some 260 laying hens, the Roseville ferry, and Point Loma Assembly are just some of the labors attributed to the Jennings brothers.

Elsewhere on the Café walls are images of the Portuguese fishing industry. The majority of early Portuguese immigrants earned their incomes from tuna fishing, thus the area's moniker,

Tunaville. Yellowfin and skipjack tuna were fished with bamboo poles, bait boats, and eventually the recognizable purse seiners.

Point Loma High baseball struggling at the plate and in the field

The Pointer baseball team, which started the season with a 4-0 mark, has fallen on hard times following that perfect start.

Since then, the team has won just once in a 13-game streak, going 1-11-1 since Feb. 25. Head coach Jeff Solis and his staff are searching for ways to return the team to its winning ways. Ironically, the team is just 2-7 in home games at David Wells Field.

The current woes are new to Solis whose teams have posted a cumulative record of 50-21-2 over his first three years. A look at team statistics tells much of the story.

Hitting: Junior outfielder Jordan Otjen leads the Pointers with a .453 batting average while the team's average is .231. Removing Otjen's numbers lowers the team average 59 points to a paltry .172. The team has scored in just 20 of 91 innings during the recent streak, totaling 30 runs and leaving 110 runners on base.

"We're having trouble at the plate, not executing," Solis said. "When the team needs a run or two, hitters have not been successful in scoring runners. With a runner at third and one out, we should score and get the job done. The run can score by putting the ball in play or a sacrifice fly. A run here, a run there. In the bottom of

the seventh (final) inning if we lose 4-2 or 5-4 those (missing) runs really kill you."

Fielding: The team has officially committed 55 errors over the season for a .934 overall average. But what is not counted are the many overthrows, bounced throws, dropped balls, and mental errors that have cost the team runs and even games.

"In the past, we've told the players 'We have to do the little things well,'" Solis said. "'Field the ball, throw it to the first baseman and hit him in the chest.' It's that simple and we're clearly not doing that now."

Pitching support: The team's 11 pitchers have walked 58 batters and hit 19 others in 108.1 innings to put 77 runners on base. Of the 80 runs surrendered by the Pointers, only 60 were earned (staff ERA is 3.88) and many runners have advanced or scored as a result of fielding and throwing mistakes.

"Our pitching has been really good," Solis observed. "The issue is not giving them run support or playing great defense."

In Western League play, teams play a three-game series against each other and the Pointers have already played both St. Augustine (No. 4 in CIF) and Cathedral Catholic (No. 15 in CIF). The Saints defeated the Pointers twice with one extra-inning game called a tie after 10 innings for darkness. The

Pointers' lone victory since Feb. 25 was a 4-1 home victory over the Dons on April 6.

"The Western League is one of the better leagues in Southern California," Solis said of his team, which is ranked 29th of 104 teams in the San Diego CIF section and 19th of 20 in Div. I.

The road ahead will be rocky even if the Pointers are able to raise their level of play. Stamina will be a key factor for the rest of the season with 10 games coming over a three-week period that began on April 19.

This week the team traveled to Orange County for the Boras Tournament, which had them playing Tuesday, Wednesday, Thursday, and Friday, a severe test of both team depth and pitching.

The Pointers then close the regular season with two Monday-Wednesday-Friday series. First is Scripps Ranch (currently 8-10) the week of April 25 followed by Madison (currently 12-6) the week of May 9.

"With the exception of Eastlake (an 11-0 loss) we've been in every game," Solis noted.

Grant keeps Correia Middle School swim program afloat

Correia Middle School has received a grant from the Prevent Drowning Foundation of San Diego, an

organization that wants to teach every child in the city how to swim. The grant will fund a program created by eighth-grade physical education teacher Jill Kinser.

"It's just part of physical

education class," Kinser said. "All eighth graders take a swim class."

Kinser created the program nine years ago to make sure that all her students would become confident in the water.

"Being from San Diego, we're surrounded by water, whether it's pools, rivers, lakes, and the ocean," she said. "I just think it's really important that all kids know how to swim for basic life-saving reasons, for safety, and to be able to participate in activities around the city and feel confident."

Her goal as a physical education teacher is to teach students a variety of lifelong ways to stay healthy. Not everyone likes to run or participate in on-land activities, and swimming is a great form of exercise to practice as an adult.

Correia Middle partners with the Ryan Family YMCA, which is in walking distance of the school. All students are grouped by ability and receive six lessons in the pool. The instructors teach them basic swim strokes, how to float and how to get out of a pool if you fall in, all the way up to teaching Olympic-style swim strokes, depending on the level of the students.

"We're so lucky that we're right next to the YMCA so we're able to develop a partnership and kind of have a shared-use agreement," Kinser said. "It allows us, a public school, to be able to swim there so we're really lucky."

Kinser's students are typically a

mix of different swim levels, anywhere from beginner to intermediate, and advanced.

"Over the years, I have been surprised; it's been about 20% of our students who are at the beginning to non-swimming group," she said.

"So each year we have a handful of students that have a complete fear of the water, can't put their face in the water, can't float, so we work them through that."
