Pacific Beach driver pleads guilty to killing architect Laura Shinn

A Pacific Beach man who was under the influence of drugs when he killed architect Laura Shinn on her bicycle will be sentenced on Feb. 6 and has agreed to accept 13 years in state prison.

Laura Shinn

Adam David Milavetz, 39, has agreed to contribute \$50,000 to the Americans Institute of Architects San Diego, according to court records as part of his guilty plea on Jan. 5 in San Diego Superior Court.

The only charge dismissed against Milavetz was second-degree murder, as he pleaded guilty to the rest of the charges which included possession of methamphetamine, fentanyl and narcotics paraphernalia, driving under the influence of drugs, and driving the wrong way on a highway.

Judge Polly Shamoon accepted the guilty pleas, dismissed the murder charge, and set sentencing for Feb. 6. The victim's family watched the proceedings online. Milavetz remains in jail without bail.

Shinn, 57, was an avid bicyclist and was riding to work on Pershing Drive in North Park on July 20, 2021, when Milavetz struck her from behind in a bicycle lane with his 2011 Prius at 7:30 a.m.

Shinn was the director of facilities planning at San Diego State University and at the time she was board president of the American Institute of Architects San Diego.

Her legacy includes the Laura Schinn Diversity in Architecture Scholarship that is granted to students in high school, community college, graduate and post-graduate students at accredited schools of architecture.

NATIONAL PIZZA DAY – Three distinct pies in Pacific Beach deliver supreme, spicy, and Sicilian flavors

Two relatively new restaurants to the Pacific Beach scene and one OG will keep your mouth happy for National Pizza Day on Feb. 9 with three distinct approaches to the textures and tastes of pizza.

Sauced Pizzeria's Supreme pie with a crispy thin crust, Hoboken Pizza & Beer Joint's thick Sicilian squares, and The Friendly's spicy pepperoni, bacon, and jalapeno contrast in styles, techniques, and flavors, but all are worthy of seeking out for a mouthwatering meal.

SAUCED PIZZERIA

This spot at 4475 Ingraham St. has been an Italian restaurant for more than 70 years. When Christina Cunningham bought Marino's Italian Restaurant in 2021, she knew she would continue the family-owned Italian restaurant tradition for that location – albeit with some sprucing up. The red and black tiled floor remains, as does the old upright piano (played on Friday nights by an MBHS music student), but the kitchen is upgraded along with the menu, which now includes vegan options.

And now, out of their massive old-school pizza ovens, come some of the best pies in PB. The most

popular, the Supreme, is piled with just about all the veggies and meats in a red sauce, on a delightfully light and crispy crust, and covered with a mix of cheeses. The ham, the fresh sliced red onions, the well-seasoned sausage, and the crunchy green peppers come

together for a feast on your tongue.

"One bite and you can taste why it's our most popular pizza," said Cunningham, whose nephew, Chad Fields, is the executive chef.

There are numerous restaurants serving palate-pleasing pizzas of every imaginable style and flavor in La Jolla. In honor of National Pizza Day, we highlight three places with different styles of pies, but all with one thing in common – they're delicious.

SAMMY'S WOODFIRED PIZZA

"Sammy's Woodfired Pizza (702 Pearl St.) made a name for itself when it opened in its first location in La Jolla in 1989 with the first woodfired oven in San Diego County," said Amy Bulgatz, the restaurant's president/CFO. "Since that day, all the pizzas are

made with hand-made dough that is made daily and stretched to order. We make our tomato sauce in-house, and only use the freshest vegetables, high-quality cheeses, and all-natural meats. The unique combination of ingredients is what has kept people coming back for the last 34 years."

Bulgatz added Sammy's has recently started a competition that is held on National Pizza Day on Feb. 9, where members of the media compete to get their own pizza recipe on the menu, and proceeds go to the charity of their choice. "Heather Lake's Hot Honey Pizza has been on all Sammy's menus and is soon to be replaced with this year's winner. Look out for that addition," said Bulgatz.

PIAZZA 1909

Pies at Piazza 1909 (7731 Fay Ave.) are the handiwork of chef Stefano Ceresoli. "Stefano's specialty has always been a bakery, since the time in Milan where he owned a bakery for many years," said restaurant spokesperson Roberta Ruffini. "The love his big hands put in the dough definitely shows. Making pizza is an art and in Italy, there are several styles."

Added Ruffini: "Being from North Italy, Stefano makes thin-crust pizza. But another delicious style popular for catering, and to make at home, is the 'Pizza al Taglio' baked in large rectangular trays, and sold in square slices at every Italian bakery. Stefano's many years of experience and the

use of high-quality ingredients, all imported from Italy, make Piazza 1909 pizza one of the best in San Diego. No secret, but un-bleached Caputo Flour from Naples, San Marzano Tomato Sauce, D.O.P. Mozzarella, and the dough left to rise for at least 18 hours are all responsible for the pizza's quality and taste. Also, try his delicious gluten-free pizza made in-house."

AMERICAN PIZZA MANUFACTURING

American Pizza Manufacturing, at 7402 La Jolla Blvd., is an original and dedicated take-n-bake pizza concept. APM's mission is to get people around the dinner table more often by elevating the at-home dining experience with

fresh, scratch-made pizzas, pastas, salads, desserts, and more, using locally sourced, artisanal ingredients that are designed to bake at home in mere minutes. Convenient homemade quality meals that require no prep, and little planning, and with big advantages over standard take-out options. APM is redefining the at-home pizza experience in La Jolla and beyond. Quality food for quality time. A host of specialty and customizable options with delivery, online, and app ordering are available. APM is also actively involved in local fundraising, distributing nearly \$12,000 to various La Jolla schools and organizations via its Rising Dough events, since 2021.

New electric shuttle service may launch in Pacific Beach

WOULD PROVIDE TRANSPORTATION TO AND FROM BALBOA AVENUE TROLLEY STOP

Pacific Beach Town Council and Pacific Beach Planning Group recently heard presentations from the City and the San Diego Association of Governments on the launch of a new shuttle pilot to bring visitors from the new Balboa Avenue Transit Station to the beaches and PB business district.

Shuttles are proposed to be Neighborhood Electric Vehicles, all-electric, low-speed shuttles traveling up to 25 mph. The PB shuttle will provide a new, fun, and sustainable way to travel to beach destinations. The shuttle will also provide a convenient and direct connection to and from the Balboa Transit Station (Mid-Coast Trolley extension to UC San Diego), helping people move around without relying on cars.

The shuttle, anticipated to launch this summer, is being funded by SANDAG and parking meter revenue collected from on-street parking meters in a pilot program operated by Pacific Beach Community Parking District.

“The UC San Diego Blue Line

has opened and we are hoping to expand mobility options for the Pacific Beach area by having our shuttle service add regional connectivity,” said SANDAG mobility planner April De Jesus. “As part of this, we are hoping to increase different options for mobility throughout the region, as well as talking about different mobility hubs adjacent to this blue line service.”

De Jesus said the PB shuttle pilot service is hoped to serve as a model for interconnecting the rest of the region with the

completed UC San Diego Blue Line Trolley extension. “It’s anticipated to be a two-year pilot project with the City and SANDAG,” she said. “We’re hoping that this pilot can teach us a lot about the ways in which the community will respond to the shuttle service so that we can replicate this throughout the rest of the San Diego region.”

Krystal Ayala, City program manager for community parking districts and shared mobility programs, said there will

be a tie-in between the shuttle pilot and PB’s Community Parking District formed in 2005.

“They are proposing the installation of parking meters within the Pacific Beach community, which is really important because this is going to provide a sustainable resource to be able to launch this service,” Ayala said. “Without having this key revenue source, it would be really hard to be having this conversation today. So we’re excited to be moving this

forward and learning about this together.”


Of the PB shuttle, Ayala said, “We are proposing deployment of the NEV, a very small, low-speed all-electric vehicle you’ve probably seen roaming around Downtown. Because of the size and speed of the vehicle, they are ideal for short trips to and from a transit station. It really allows us to change the supply as demand fluctuates so, as there may be a seasonal increase in riders wanting to use the service, you’re able to more easily deploy additional vehicles because of their smaller size.”

Concluded Ayala: “We’re really excited to be bringing this service to the community. There has been a lot of momentum throughout the region. Many other neighboring cities have been launching shuttles similar to his one. We’re really excited to test the beach-use case, and see how the shuttle can better serve our beach communities, but also make that really important connection to it from transit.”

Ayala noted a lot of the details of the PB shuttle pilot are yet to be determined, adding the City and SANDAG will be returning with updates for stakeholders including more fleshed-out details prior to the start of the PB shuttle pilot.

City of San Diego starts enforcement of sidewalk vending in beach areas

On Feb. 1, the City of San Diego started fully enforcing the Sidewalk Vending Ordinance in City beach areas after the ordinance became effective in the Coastal Overlay Zone last month, following certification by the California Coastal Commission and the City Council.

The ordinance went into effect in June 2022 in all areas outside the Coastal Overlay Zone, bringing the City into compliance with Senate Bill 946, a California law that decriminalized sidewalk vending statewide and set parameters on how cities could impose regulations. However, implementing and enforcing the sidewalk vending regulations within the Coastal Overlay Zone required certification of the Coastal Commission and City Council approval of any modifications to the ordinance in this area.

The Sidewalk Vending Ordinance requires pushcart and stationary sidewalk vendors to apply for permits to use the public right of way or public property while regulating how, when and where permitted sidewalk vendors conduct business. Sidewalk

vendors are explicitly prohibited from interfering with public access to the shoreline. In addition, the

ordinance bans sidewalk vending in the Gaslamp Quarter and other specified areas.

Over the past several weeks, City Park Rangers have been sharing educational materials with

vendors to outline the parameters of how they can operate legally in and around beach communities. Vendors operating illegally may be cited for violations and subject to fines ranging from \$200 to \$1,000, depending on the number and types of violations. Carts, equipment, and goods may also be impounded.

Since the Sidewalk Vending Ordinance went into effect last year, more than 500 sidewalk vending permits have been issued to local vendors selling jewelry, clothing, apparel, artisan products, home décor, candles, fine art collectibles, novelty items, food products, among a wide array of other items.

All pushcart and stationary sidewalk vendors operating within the City of San Diego are required to have a valid and current Business Tax Certificate, Sidewalk Vending Permit, and City issued photo ID. Food vendors must also have a San Diego County Health Permit and Food Handler Card. More information about permits and the application process is available at sandiego.gov/sidewalk-vending.

Fields, who had previously worked in pizza shops, took a little from here and there and fine-tuned the dough and sauce to react perfectly with the 650-degree ovens in the salty coastal air. The result is a masterpiece.

“Our pizza reviews are amazing,” Cunningham said. “We love that local families, who have been coming to this spot for generations, keep coming back. Now, we are all part of a new family.” saucedpizzeria.com.

HOBOKEN PIZZA & BEER JOINT

This ode-to-Jersey pizza place at 1459 Garnet Ave. has been sling- ing NY/NJ-style pies in Pacific Beach since 2002 and has won over countless East Coast-biased critics for decades. “I think we have the best New York-style pizza around here. Who’s better?” asked

longtime owner Tony Kruk, who still makes the sauce every morning, from a recipe ingrained in his

brain that’s not for sharing.

The round pie has the credentials, but it’s the thick, square Sicilian with the Tri-State bonafides. “People come in here only for that pizza,” Kruk said. “The original owner (from Jersey) taught me everything. This Sicilian pie was his recipe.”

Sicilian pizza is a process. It takes a lot of time and effort, every single day. “It’s kind of a pain in the ... but it’s unique and you can’t find it like that anywhere else around here,” Kruk said. “That’s why people keep coming back for it. We’re dependable. Our food is consistently good. That’s the reason locals have kept coming in for 20 years. And we appreciate that.”

The thick pie is cooked to golden cheese perfection with pepperoni, some sausage that crisps on top, a thin layer of red sauce, and those corner slices with the crunch of the crust. Like North Jersey, it’s something that has to be experienced

The Dirty Flat Top cheeseburger may have put this North Park eatery on the map, but don’t overlook the spicy and savory pizza options. The Pacific Beach outpost, at 1344 Garnet Ave., opened in 2022 with a no-frills dining room and outdoor seating in front. Diners can order whole pies or by the slice from the display case, and there are plenty of satisfying selections available.

The most popular pie is the pepperoni, bacon, and jalapeno, followed closely by “The Becky,” a white pizza with mushrooms and ricotta cheese.

“The crunch of the bacon, the spicy jalapenos, and the meaty pepperoni, it just makes sense,” said The Friendly manager Bruce Heelan. “The mushroom and

ricotta pizza is also trendy – one of our best-sellers.”

To give the mushrooms an added pop, they are cooked Duxelles style – a French technique with shallots, herbs, and sautéed in butter. “I don’t think any other place does that, it really adds to the flavor,” Heelan said.

The locals who started the original eatery in 2018 had all worked in the restaurant business for years and put their heads together to come up with interesting flavor combinations – such as the “Did I Tell You I’m a Vegan” pie, which has Diya cheese, garlic, spinach, red bell pepper, mushrooms, red onion, and artichoke hearts. Somehow, it all works. @thefriendlysd.

Any way you slice it, the options in Pacific Beach will satisfy any pizza cravings you have and keep you satiated on National Pizza Day and beyond. Now, that’s amore.

Notable Babcock Residence in Mission Beach changes hands for \$4.95M

A one-of-a-kind showplace home in South Mission Beach, the Babcock Residence at 2694 Bayside Walk, recently sold for \$4.95 million.

Designed in 1959 by Mission Beach native Kendrick Bangs Kellogg for Russell and Vergie Babcock, who requested an "A-frame" with a copper roof, and constructed in 1960, the home was originally listed at \$5.68 million. Chris Love of Coldwell Banker Realty was the listing agent.



Steps from the ocean and bay, the 2,607-square-foot, 4-bed, 4-bath residence has a 4-car garage and two additional uncovered parking spots. The home features panoramic unobstructed views with water visibility throughout.

The outdoor/indoor open living concept allows for entertaining guests while giving the feeling of being directly on the white sands of Mission Beach. The property sits on one of the largest corner lots in South Mission Beach.

"This really is not only an iconic home for Mission Beach but for all of San Diego," said Love adding the residence "is really special." She pointed out that the previous owner had it for almost 30 years, and "we were lucky enough to find a new buyer from Arizona who'd had his eye on it."

"Everybody knows this home all over California – all over the world," said Love. "It is a piece of art and everybody in the community knows it. As the listing agent, I was so honored to be able to be involved in that sale."

Of her career, Love, now in her 46th year transacting real estate in Mission Beach, said, "This is one of the highlights, if not 'the' highlight."

Kellogg met Frank Lloyd Wright briefly in 1955 while attending the University of Colorado at Boulder and was heavily influenced by Wright's architectural style. The Babcock Residence's design is reminiscent of Wright, who used organic architecture to plan the 800 buildings he designed, 380 of which were actually built. Using the environment around where the



structure would be, Wright would design and build accordingly, resulting in unique structures and homes that fit their landscape.

Wright designed two projects for San Diego but they were not constructed. The first, the Russell Babcock Residence (1953), went unbuilt on its projected lot on Mission Cliffs Drive in University Heights.

Soon after the project failed to be realized, Babcock hired Kellogg to realize his Wrightian dream home to be built on Mission Bay.

The Babcock Residence jump-started Kellogg's career and he since has designed and engineered more than a dozen startling residences, most notably the Surfer House in La Jolla, the High Desert House

in Joshua Tree, and the Onion House in Kona, Hawaii.

Kellogg's distinctive aesthetic has been described as "an architecture so full of life that it seems to breathe," and his residences have been chronicled as

"the Sydney Opera House meets Stonehenge."

Said Kellogg: "To realize truly creative architecture you need clients with the vision and imagination to make the most of any site. Pacific Beach Town Council held its annual installation dinner on Jan. 21 at Mission Bay Yacht Club, with new board president Charlie Nieto hosting an awards presentation that included naming PB's Honorary Mayor for 2023.

Pointing out he joined the PBTC board just two years ago in the middle of COVID, Nieto said: "I have the privilege of speaking in front of such a diverse body of community members, first responders, business owners, and elected officials. For 72 years, without skipping a beat, even through the pandemic, all of us from different walks of life in PB have gathered together on this night to be a part of that history."

About himself, a PB native, Nieto quipped: "You may ask yourself, who is this guy? Who does this 20-year-old think he is? I can now say that PB Town Council, the oldest town council in all of San Diego founded

MURAL INSTALLATION DELAYED IN PB

The surfboard flower-petal community mosaic mural to revitalize the 65-year-old Pacific Beach Rec Center is ready to go. But actual installation has been delayed to comply with new City regulations.

"We got the building permit last year and we thought we were ready to go but there was a lot of other paperwork that the City Attorney needed to sign-off on," said Brian Curry, spokesperson for the mural project. "The artist, Rob Tobin, is done with the boards, he is ready hang them, and they are being stored at the rec center."

Curry noted the mural will be a gift to the City on City-owned

property. Recently, the City attached more conditions to final approval of the project, including the hiring of a structural engineer. "The City wants to ensure that the integrity of the (building) wall will not be comprised, and the PB Town Council has hired a structural engineer to address these issues," said Curry noting the project has been about four years in the making. He added an official installation/dedication date for the mural has yet to be determined.

Known as the Pacific Beach Community Surf Garden, the project involving 64 donated and tiled surfboards and some 150 volunteers, was conducted for several weeks during volunteer workshops

at the PB Rec Center at 1405 Diamond St. There are five tax-deductible sponsorship levels for surf tiles being purchased to pay for the art project by donors ranging from \$50 to \$5,000. The more someone donates, the bigger the personal tile they are entitled to.

For more than 30 years, Play It Again Sports in Pacific Beach has struck just the right balance between selling new and used goods serving the sports and recreational needs of the beach communities and beyond.

"It's about 50-50, we try to balance," said owner Fred Princen of his new-used retail mix at 1401 Garnet Ave. The store carries literally thousands of individual items including surfboards, skateboards, in-line skates, paddleboards, fitness equipment, golf clubs, snowboards, and bicycles. Play It Again's inventory offers all the accouterments for seasonal and year-round sports activities of every imaginable type, including relatively new and increasingly popular pickleball. The shop also sells apparel associated with whatever sport or activity customers are interested in.

"The system has always been the same," pointed out Princen, adding customers have choices when they come in. "People come to trade the old items they've

outgrown or want to part with," he said. "We make them three offers based on how much we can sell their item for cash, a trade-in with six-months store credit and consignment, where the item remains the customer's property until it is sold, and then we do a 50-50 split. I buy back what someone purchases giving the same margin when we buy, 30% to 35% cash back, 40% in trade-in or selling on consignment."

Princen talked about their biggest-selling item right now in mid-winter. "We are one of the biggest retailers when it comes to snow sports offering something that is good quality at an affordable price," he said.

One of the biggest challenges Princen has in marketing his store is branding. "People don't realize how much stuff we have," he said adding the three Play It Again franchises in San Diego County are

individually owned so that "every store is unique."

Merchandise in Play it Again is compartmentalized and seasonalized, prioritizing those sports and activities that are in season.

Open since 1992, Princen has owned Play It Again for the past nine years. You can be any age

to buy in the shop but must be 18 years or older to sell.

In terms of the deals they make with customers, Princen said: "It has to be a balance between the margin we need to make, and how much the person is going to have in return. That's why we do the three offers."

Princen noted his shop is good for those starting out in a new sport or activity because it allows them to buy things at a less-expensive entry level to determine whether it is something they wish to pursue further. Or, it can be useful for someone seeking less-expensive non-name brand products of high quality.

Play It Again Sports prides itself on the fairness of the deals it strikes with customers in transactions. "Customers come in and they go, 'You get all that and at that price?,' said Princen adding, "So many people say, 'I didn't know you handled that.' Or, 'You only do used, I'm not sure you have this or that.'"

The successful business model at Play It Again is no secret.

"We get new – or used – that is quality at a price that is affordable with all the choices we have," said Princen concluding, "We're the only store around, for example, that you can find that selection of snowboards, or surfboards, at that price."

Airport and brewery collaborate to release beers made from purified condensate

San Diego International Airport (SAN) and The East Village Brewing Co. celebrated the release of two beers made with purified condensate collected

through the airport's water stewardship program. Hoppy Travels IPA is a West Coast IPA with flavors of grapefruit and guava and Pre-Flight Pils is a German-style

pilsner with bready and lemon zest flavors. The beers are currently on tap at The East Village Brewing Co. and will be available at San Diego International Airport's Terminal 2 in the coming weeks.

The water used in the beers is the condensate that dripped from the bottom of air conditioning units attached to jet bridges at SAN. The captured condensate was then purified using reverse osmosis and ozone disinfection and transported to The East Village Brewing Co. for its use. The condensate water has a pure water profile with little mineral content, making the reclaimed water an ideal base for brewers. In addition to making beer, the water is used to clean equipment and vehicles at SAN as well as in the cooling towers that control the temperature in the terminals.

"We first partnered with the brewers of The East Village Brewing Co. in 2019 when they brewed a beer called SAN Test Pilot using the condensate while working at another local brewery," said Kimberly Becker, San Diego County Regional Airport Authority president and CEO.

"The beer was very successful, selling out almost immediately, and since then we've been interested in collaborating again. The East Village Brewing Co.'s focus on sustainability aligns with our efforts at the airport and we are happy to have the opportunity to showcase this reclaimed water innovatively with their help. Cheers to another successful collaboration," Becker said.

"Wholesome ingredients, sustainability, and community are the core tenets of our brewery," said Aaron Justus, The East County Brewing Co. owner and brewer. "This collaboration checks

all three boxes. It's great to partner again with the airport, a pillar within our community filled with passionate and fun people. The condensate water is superbly pure and ideal for brewing. Plus, it's no secret that California is in the midst of a long-term drought, so water reclamation is a creative way to reduce our water footprint here in San Diego."

The East Village Brewing Co. has an emphasis on sustainability, ensuring its operations, brewing practices, and final products limit the impact on the environment. Some examples include sourcing hops and malt ingredients from certified Global GAP and Salmon Safe farms, providing their spent grain to a local farm for cow and pig feed, and sourcing all raw materials from companies located on the West Coast of the U.S.

In addition, all water that runs through the heat exchanger is reclaimed and used for cleaning and brewing, lights are low energy LED and have either timers or motion sensors, cleaners, and hand soap for the tasting room and bathrooms are earth friendly. The brewery is paperless and

THE ESSENTIAL OBJECTIVES OF ESTATE PLANNING

The essential objectives of estate planning are:

1. To eliminate or minimize probate fees. "Probate fees" are attorney's and executor's fees allowed by law in a court-supervised "administration" of one's estate. One means of eliminating, or at least reducing probate fees, is by your creating a revocable living trust.

2. To eliminate or minimize federal estate tax ("FET"). If you are married and have a substantial combined net worth, be sure to take advantage of "portability" – the addition of the first spouse to die's unused lifetime exclusion amount (from federal estate taxes) to the surviving spouse's lifetime exclusion amount. To obtain this portability present law requires the filing of a federal estate tax return following the death of the first spouse to die.

In this connection, to reduce the size of your estate, and without requiring your filing of any gift tax return, and, therefore enabling your estate to pay less FET, consider making annual \$17,000 gifts (new amount for 2023) of cash or property value to each donee you wish. Also, the purchase of life insurance on your life may help to pay any FET owing on your death.



3. To eliminate or minimize potential Medi-Cal costs. To reduce the potential of Medi-Cal costs, consider purchasing long-term health care insurance.

4. To minimize the risk from a damage award against you (for example, from auto accident liability in excess of your coverage). One thing you can do here is purchase an umbrella liability insurance policy through the insurance company providing your auto or home insurance policies.

5. Most importantly, to be certain that your estate will pass to those beneficiaries you desire to have it by so designating them in a trust and/or will or other appropriate dispositive document(s).

Dealing with unexpected challenges of entering the world of the disabled



Doing it Better

A few months ago, I was walking 4,000 steps a day using long strides. Then, one day as I was opening my refrigerator, the handle broke in two and I crashed onto the kitchen floor. An X-ray revealed a compression fraction in the L1 disk of my spine. This was the last thing I needed. I already have bone on bone contact in my left hip that causes me pain when I try to walk. Given my fractured spine and bad hip, I am now confined to a wheelchair and require a caregiver to take me to the dining room for all my meals with friends. The rest of the time I'm in my recliner.

That's not all! My eyesight is getting worse as a result of macular degeneration. Today, for the first time, I had to use a magnifying

glass to read the paper. What a bummer! I have also been diagnosed with severe hearing loss to the point that, even with state-of-the-art hearing aids, I have trouble understanding the people across the dining room table in a noisy dining room.

I have officially entered the world of the disabled, the handicapped, the dependent. This a whole new world, like a new country, where I need to learn the language, the customs, the available resources, as well as the prejudices. I will be 97 this year. Up until now, I have a magical life with no major health issues. My current ailments are just part of the territory of living this long. Trying to accept these new infirmities is not easy. The image I have of myself has not yet changed from an independent, take charge, outgoing, mobile and fun person. I have turned into a dependent, homebound, vain person — not liking my new image in a wheelchair.

Perhaps I need to turn things

around by trying to write this transformative narrative by changing my language. Maybe "disabled" is not all that I am. I am still the same person I always have been, but currently with some disabilities. This shift in perception limits the negative aspects by not taking away from my basic personality. I am still a writer; I still do research. I have stimulating conversations with friends. I read, think, and can tell jokes about my new predicament.

I'd like to take this moment to share a joke: So, this woman goes to the doctor and says, "I have broken my arm in two places. What should I do?" The doctor replies, "Don't go back to those places." This column is my passport for entry into that new world that includes some short-term memory issues. I'll get up from my chair to do something; then I forget what it was I wanted to do... oh well.

The rest of my story continues: our White Sands doctor, Dr. Sadaf Najand, prescribed different pain

medications, all of which gave me unpleasant side effects. I can only take Tylenol, which doesn't do much for the six hours until the next dose. Even more than pain, I mind the constant feeling of exhaustion, low motivation, with everything being an effort.

As far as my pain — it is debilitating. A friend of mine researched pain clinics in my vicinity and found the Relive-You Center for Advanced Pain Management. Their clinic is located at 8901 Activity Road, San Diego 92126; 858-345-4646. It is about 30 minutes north of La Jolla. In the front of a welcoming new building the sign states its mission: to release people from pain. Dr. Brittany Grove and her husband Dr. Gemayel Lee run this facility with their professional staff. They both have an MD from UCSF with fellowships from UC San Diego in chronic pain, and are board certified members of the American Board of Anesthesiology. I took comfort knowing that I am in

competent hands.

Upon arrival, my friend and I were led into Grove's examining room, where she checked where my pain seemed to be the worst. She concluded that she would inject a numbing agent into the femoral nerve joint. Within minutes after the injection, the pain disappeared for a couple of hours. This was a test to determine whether she indeed hit the correct nerve to be numbed...Success!

At my next visit, I am scheduled to have both Grove and Lee numb my femoral nerve for a more permanent solution. I am grateful to have lived as long as I have — to be able to see and experience the many advances in science and medicine. Hopefully by the time you are reading this I will be walking again!
