**City breaks ground for new Cañon Street Pocket Park**

A decade-long effort to create a Portuguese-themed Cañon Street Pocket Park in Point Loma finally came to fruition with an Aug. 16 ground-breaking with Peninsula residents joining District 2 Councilmember Jennifer Campbell and City staff onsite.

Construction for the new pocket park over the next year is to include a children's playground, picnic areas, walkways, landscaping, safety lights, storm drain systems, landscaping, irrigation, fencing, and a public art piece.

"It would not have happened without Don (Sevrens) and it's a tribute to perseverance for the community," said Peninsula Community Planning Board president Fred Kosmo at the ground-breaking. Discussing obstacles Kosmo noted: "The main one was trying to get the funding for the park, and then the delays. We'd get a budget, and then they (City)

## CITY COUNCIL RATIFIES DECLARATION OF EMERGENCY AFTER TROPICAL STORM

On Aug. 21, San Diego City Council ratified a declaration of emergency by Mayor Todd Gloria following the disruption wrought by Tropical Storm Hilary over the weekend. The Council vote was unanimous, 7-0, with Councilmember Vivian Moreno and Council President Sean Elo-Rivera absent.

At least one of a handful of people testifying during public testimony at the half-hour afternoon session questioned the need for declaring an emergency at all. One person testifying referred to the emergency declaration as a "fake storm" and another called

it a "money grab" for federal and state emergency relief funds.

Councilmember Joe LaCava representing La Jolla and District 1 said: "Preparation paid off, the message got out. The whole City team singularly functioned to protect San Diegans and our vital infrastructure and businesses. We do amazing things when we're all working together. We've seen a good example of that over the past few days."

Former San Diego Assemblymember Lori Saldana decried the City's handling of evacuation during the tropical storm saying "the job of preparing unsheltered people was non-existent."

## Ocean Beach building an ambassador program

Two Ocean Beach civic organizations have teamed to create a concierge-like volunteer ambassador program to educate locals and tourists about all the community has to offer.

"The Ocean Beach MainStreet Association, along with the OB Town Council began the Downtown Ocean Beach Ambassador Program this past April and our dedicated volunteers have been out and about each Saturday," said Kristen Keltner, OBMA's event and program manager. She noted the business improvement district's Clean and Safe Committee chairperson, Matt Kalla, has been exploring a community ambassador program for some time.

"Matt has looked at what programs several other communities, such as Oceanside and San Luis Obispo, were doing," said Keltner. "OBMA's Clean and Safe Committee is committed to seeing this program grow. We've received a ton of good feedback from the community and business owners. So our goal is to increase awareness and volunteers for the fall and winter."

Volunteer beach ambassadors set up a booth at Veterans Plaza Park each Saturday from 8 a.m. to noon. They direct visitors to restaurants, retail shops, beach rentals, public parking, and public transportation as well as provide general event information. They also provide information about current and future OBMA and OBTC programs, projects, and initiatives. They are also tasked with collecting pertinent data from visitors and locals to help improve future visits to downtown Ocean Beach.

Noting OB Ambassadors are taking time to "get up and running" and to "gain traction," OBMA board member Kalla said volunteer community ambassadors have become the community's "eyes and ears acting like concierges for folks visiting the town. The whole idea is that they serve the community by making people who come here more comfortable to walk the streets, and to acquaint people with OBMA

business owners and steer people toward them."

Kalla said the hope is that the OB Ambassador program will become successful enough to "continue it year-round."

Anna Firicano, one of the ambassadors who lives on the top of the hill in the community, said she got involved with the program out of a sense of community commitment. "I'm just one of the people in the neighborhood who just got frustrated with all the crime and all the homelessness and how dirty everything is getting," she said. "I thought this would be a great opportunity to get into town, meet people and talk up our local community organizations and get people excited about volunteering for OB. And, while we're (volunteers) at it, we're picking up trash and sweeping."

Added Firicano: "It just feels like a win. Every time we set up down there (Veterans Plaza) we find people who didn't know there were opportunities to volunteer, and they sign up. It's little baby steps. But I think in the long run we're getting people excited to be in the community and do good things."

"We need to change the perception that people have of OB. Sitting on my couch and posting on Next Door (social media) isn't helping anybody or anything. I did it (ambassador) and it's been great."

Look for ambassadors in OB wearing bright yellow vests who are welcoming visitors and locals to Ocean Beach and providing them with information to help them explore the area and enhance their experience while visiting the eclectic town.

If you would like to volunteer for this program, the Ocean Beach MainStreet Association and Ocean Beach Town Council are seeking highly enthusiastic individuals ages 16 and older to serve weekly as ambassadors for two, two-hour Saturday shifts from 8-10 a.m. and 10 a.m.-noon.

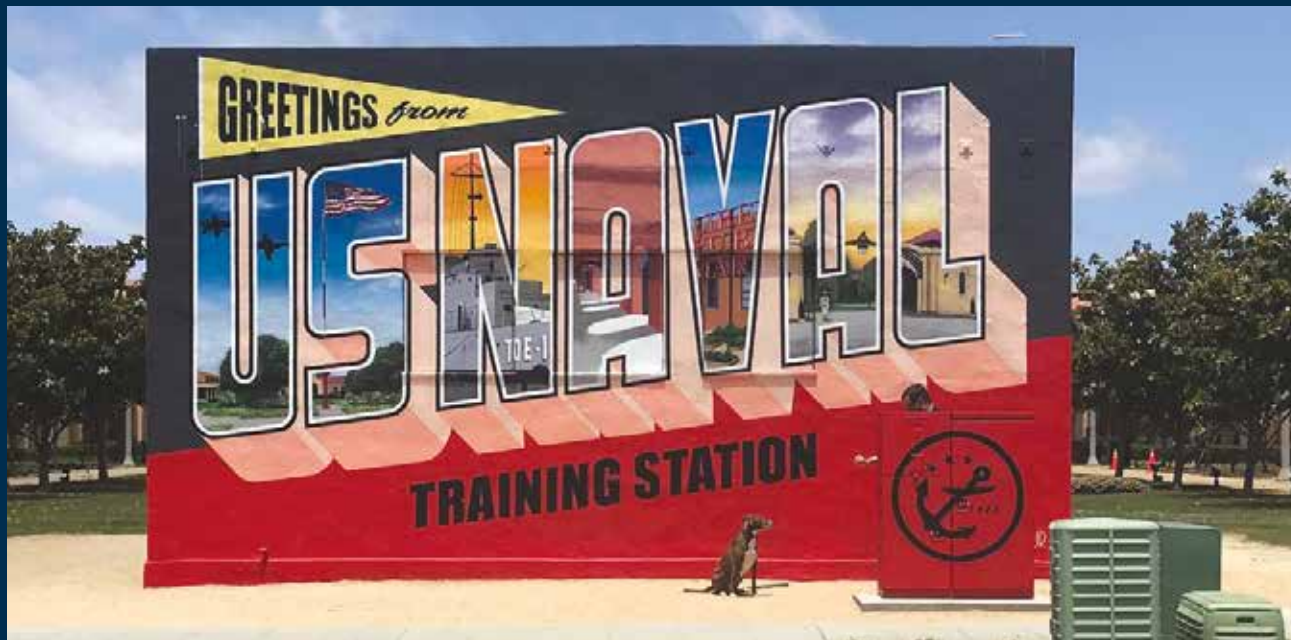

# The Britannia Tearooms is a wonderland of British-themed fun

If you like “Alice In Wonderland” and “Harry Potter,” you’ll just love The Britannia Tearooms, San Diego’s authentic British

tearoom, food, and gift shop in the Midway District. You may even see Alice popping through a “rabbit hole,” as she does in some of the whimsical rooms of the British family-owned and

operated business. The tearoom has taken over for the Old Waffle House at 2323 Midway Drive. It’s all things British at The Britannia Tearooms which boasts, among other things, a Sherlock Holmes sitting room, a Mad Hatter’s Tearoom, numerous references to “Alice In Wonderland-Through The Looking Glass,” and a Mary Poppins-themed gift shop. There are even Harry Potter-themed bathrooms. It’s the only place in San Diego to drop in for a proper British afternoon tea. It’s not brunch – it’s an experience, noted owner Selina Stockley, who pointed out that tea is something special in British culture. “Tea is obviously the No. 1 drink in Britain,” she said noting, “Tea is drunk from the moment you wake up, to the moment you go to bed.” Added Stockley: “But if you’re talking about partaking of tea, there’s all different levels of it. You could just be sitting down to something informal. Or you can have your friends over and it’s a bit more formal. It’s very much a part of when you go out and shop. It (tea drinking) is just more usual than it is here.” The Britannia Tearooms started out years ago in Shakespeare’s Corner Shoppe & Afternoon Tea, a British grocery at 3719 India St.

where Stockley was first general manager and then owner. Her new Midway location now features a traditional English tearoom on its patio with food freshly prepared and served from an in-house English bakery. Over the last 22 years, Stockley has built business enterprises true to her cultural roots using tradition and authenticity as her guides. And she truly relishes being able to share her love for all things British. “I wanted a posher tea,” said the shop owner speaking from her Shakespeare’s sitting room replete with fireplace and coat rack at the front entrance. “But I also didn’t want this fancy tea room that was too posh for everybody. So, we brought in all the themes.” Stockley, who comes from a theatrical background, said of her afternoon-themed teas held every six weeks: “I do quotes and I put on all the accents. And then we do a quiz. It’s very much an event. We, and the people who come to us, dress up in full-length costumes. They’re (guests) lovers of whatever they’ve come to watch. We have Harry Potter in September and October. This has just really grown its own legs and arms.” Stockley noted creating a storybook atmosphere, like that in her colorful Mad Hatter’s Tea Party

Room in the back where themed teas are held, has been a challenging and complex task. “With us, there’s like 20 different items on the plate and everything’s made by hand,” she said of her shop while pointing out, “The only thing we don’t make here is the crème that we import from England.” Passionate about her business, Stockley noted: “It’s very detail- and labor-oriented. I wanted to develop the whole afternoon tea and make it enjoyable for everyone. And this (Midway location) just touches on everything that I wanted.” Hailing from Surrey, England, Selina has a natural and family feel for her occupation. Having grown up watching her grandma Lucy bake in her kitchen, she dreamed of one day owning her very own tearoom. Now, with The Britannia Tearooms in America, she’s fulfilled her wish of bringing her grandma’s recipes and age-old ways of making everything by hand with authentic methods and ingredients. And all of Selina’s guests are thankful to be there for the party.

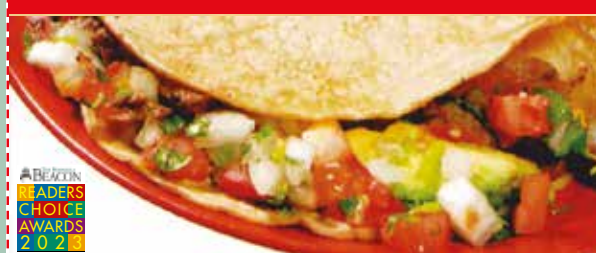

There's a new team on the Point Loma High School campus, both history-making and precedent-setting in the world of prep sports. Girls flag football has kicked off!

Newly approved by the San

Diego Section of CIF as the 31st sport at the prep level (21st that includes girls), the first games were played this week and one of them involved Point Loma squaring off against Clairemont's Chieftains on Tuesday, Aug. 22.

PLHS athletic director Manny Diaz Jr. made sure his team had all

the necessary equipment including flags, size 7 intermediate footballs, home and away jerseys for the group of about 40 who showed up for the first team practices. The turnout was so high that it was decided to field both a varsity and junior varsity team in the first year (seven play at a time).

New head coach Michelle Mannisto played college basketball at University of Detroit, has coached college and prep basketball for 15 years, and "played a lot of football." Her assistants are Krisitin Smereczynski (former college and San Diego Rebellion pro player), Britney Torreon (Elite national flag football player), and Julia Pihl (Hope College basketball player and Mannisto's former assistant coach).

With the addition of this new sport, precious practice time and space on the Pointer campus has been squeezed even tighter but Mannisto praised boys football and field hockey coaches for welcoming her team and sharing available space.

"We're all still learning the rules, including the officials," Mannisto said. "But we have athletes. Some can throw, some can catch and we're getting our depth chart set. A freshman may be our top quarterback and some girls may play both offense and defense."

Mannisto's players are excited about their new opportunity.

"I really wish this had taken off sooner," said senior Bella Sisk-Correll, "But I've always played football with my relatives growing up and I think this is a perfect chance for girls to be recognized playing football. And if this takes off, we can be remembered for being the first girls in Point Loma history to play flag football, kind of like (the baseball film) 'A League of Their Own.'"

And the practices?

"They've been a lot harder than I expected," Sisk-Correll noted, "But I like that because it pushes us and it helps us connect as a team so I appreciate the coaches pushing us."

### GAME RULES

Games are played on Tuesday afternoons at 4 p.m. and if fans aren't on hand for the kickoffs they may miss the short games, which consist of two 20-minute halves with running time until the final two minutes. Halftime is only five minutes, meaning the games will likely last less than 60 minutes.

Current CIF rules say the fields must be 30 to 40 yards wide and 50 to 80 yards in length plus two 10-yard end zones. Teams must have seven players to start a game and a minimum of five to continue

playing. All players are eligible receivers and the quarterback may run only one time per series of downs. Fumbles are dead when they hit the ground. Defenses may rush no more than two at a time and must start seven yards behind the line of scrimmage. There are no punts. Instead, a punt is "declared" and the ball is placed on the defense's 20-yard line.

In capital letters, the rules state "NO EXCESSIVE CONTACT" will be allowed." One rule that puzzled Mannisto is "No blocking or moving screens allowed at any time."

### POINTERS' LEAGUE

The new leagues are, for now, simply designated "League A" and "League B." The Pointers are in the former along with Cathedral Catholic, Hoover, Mira Mesa, Morse, Patrick Henry, San Diego, Scripps Ranch, and University City High Schools.

## Big plays hurt Pointers in season-opening loss to Madison

Point Loma's Pointers knew they had a powerful pair of opponents on their pre-league schedule and the first one used several big plays to defeat them in the season opener.

Madison High ranked No. 5 in

preseason polls, has been a thorn in the Pointers' side for years, last season going 9-2 and earning a spot in the Open Division (top eight teams in the section) playoffs before losing to eventual state champions Lincoln. So the Warhawks haven't been and still aren't pushovers as they walked away with a

35-14 win on their home turf.

The Pointers, coming off their own Div. III playoff championship appearances, are younger this year and should show marked improvement as the season continues. Still, the Pointers hung tight with their Div. I first-week foe.

The current Pointer roster includes no less than 14 sophomores, some who have earned starting positions, and only 14 seniors.

"We played them really tough on defense and battled for four quarters," said head coach Joel Allen after the game. "A couple of big plays hurt us. We couldn't establish the run on the offensive side which turned us one-dimensional."

Indeed, the Warhawks stuffed most Pointer run attempts, leaving the offense relying more heavily than planned on the passing game.

QB Max Newbegin was also under pressure much of the game, an interception leading to the first Madison touchdown. But he persevered to throw for 139 yards and two touchdowns.

The first of those scores came on a beautiful second-quarter completion over the middle to Brady Allen who repelled attempted tacklers en route to a 70-yard touchdown that brought the Pointers to within 14-7 after an Aaron Lee PAT.

Ryan Burdine blocked a Madison PAT attempt on a Warhawk score with .08 left in the first half.

In the third quarter, Allen again had a big gain to the Warhawk 10-yard line and after that, Newbegin found Romeo Carter at

the goal line who made a leaping catch of the throw for the second Pointer score with 3:10 left in the third quarter.

Returning first-team all-league linebacker Rocket Robinson spoke for his teammates.

"I think we put up a pretty good fight against a Div. I team and we held our own," Robinson said. "We need to work on team chemistry, lining up, assignments--basic stuff. It's only going to go up from here. I think we can win every game ahead."

"Hats off to (Madison), they're a

really good team," Allen said. "But we as coaches know what we've got and it's our job to convince our players what we've got. I'm really proud of our kids."

The Pointer freshmen (20-0) and junior varsity (34-8) also dropped their openers.

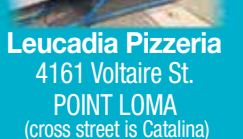

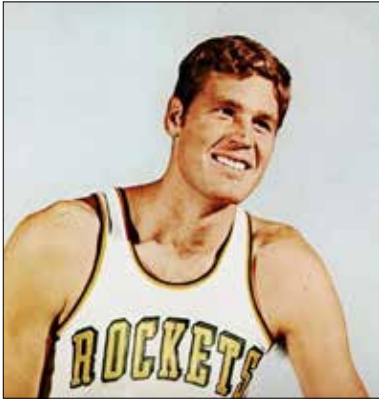


# From San Diego Rockets to PLNU, John Block helped build basketball locally

When former Point Loma Nazarene men's head basketball coach, and once-upon-a-time San Diego Rockets big-man John Block was 3, he toddled up to the family lawn mower, got on his hands and knees, and reached under the blades.

Three fingers were completely severed, but as Block tells it, it looked worse than it felt.

"The stress of the travel was a killer," Block said. "We played 13 or 14 games in 17 days once, all over the country."

In his second season, the Rockets drafted a future Hall of Fame, volume scorer, with a shoot-first, pass-last reputation: Elvin Hayes.

"I went around to my mom and yelled 'Hey look what I did,'" Block remembered. "I held up my hand and she freaked out. That was a precursor; I have had to endure pain and I have a high threshold. That was the beginning of seeing that happen"

That first lesson in pain management served Block well. In the years since he has had 33 surgeries and multiple stays in the hospital.

"I've had open heart surgery – pacemakers put in," Block said. "I've had back surgeries; I have a new left ankle; a fused right ankle; a new hip on my right side; a new shoulder on my right side."

Now, 79, Block is often found at the San Diego Racquet Club, putting his new body parts to use on the pickleball court.

"I can't take more than two steps, but I still have some good reach and hands that can hit a ball," said Block, who is 6 feet 9 inches tall.

For 10 years, Block ground down his original ankles, hips, and shoulders, on the NBA hardwood, matched up with and against the premier big men of the league during the 1960s and '70s.

"It was thrilling," Block said. "My first year with the Rockets we were playing a doubleheader in Philadelphia and [Bill Russell] was guarding me out in the corner. I made a fake and stepped through and drove to the middle. He went up and I went up and I dunked two-handed on him. I said to myself as I went down the court 'Oh my gosh I can't believe it, I just dunked on Bill Russell.' Never again did I dunk on Russell."

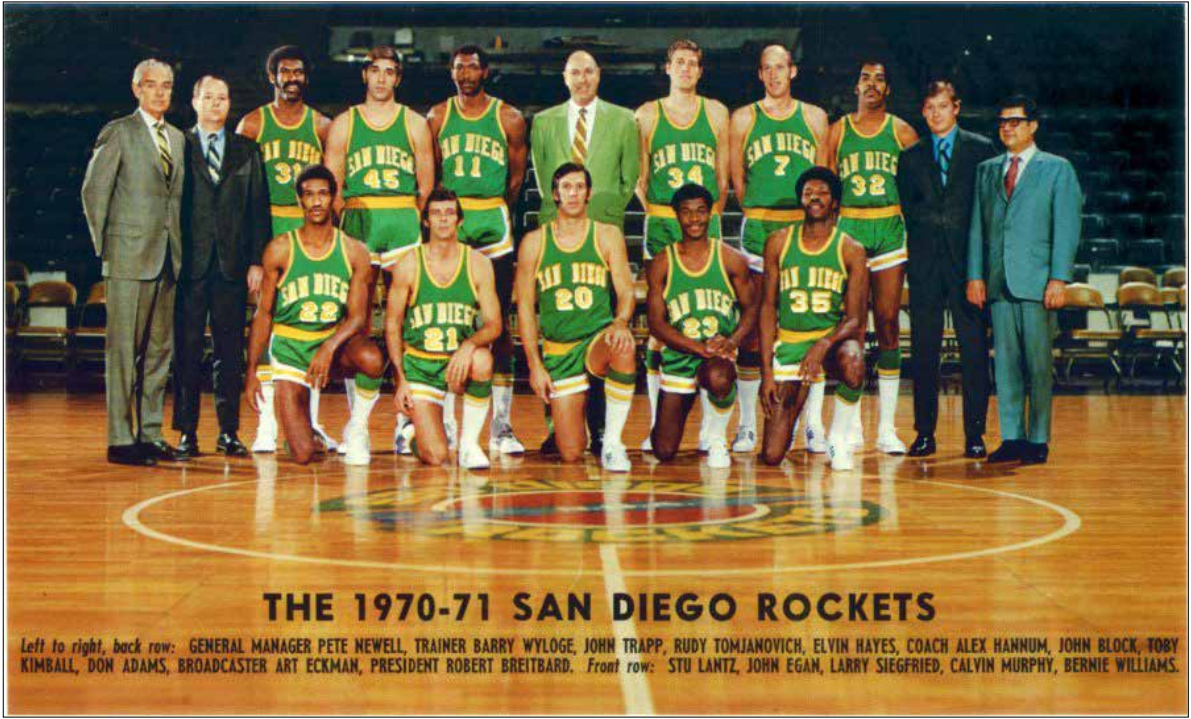
And then there was Wilt Chamberlain.

"He's the best big-man athlete who ever lived," Block said. "He was stronger than anybody; he could run as fast as any point guard; he could jump high; his physical presence was overwhelming."

In the San Diego Rockets' inaugural season [1967-68], Block came over in the expansion draft, after spending his rookie year with the Lakers, playing sparingly. With the opportunity for big minutes at Sports Arena, he averaged over 20 points per game, leading the Rockets in scoring.

"For the whole season with the Lakers, I only played 118 minutes," Block remembered. "I do not recall how I found out [about the expansion draft], but my response to that was elation. I was going to go to a team and have a chance to play."

The team struggled, losing 32 of their final 33 games.

ended his career.

"I got to play with 14 or 15 Hall of Famers," Block said. "I injured my back severely in an exhibition game my last year and never really recovered from that. I was talking to the Lakers but my rehab wasn't really coming along and one day my wife and I just looked at each other and said 'I think my career is over.'"

Block moved on to coaching, with stints at UC San Diego, Gordon College, Bethany College, and Point Loma Nazarene, retiring following the 2002 season.

"I was a journeymen basketball player and a journeymen coach," Block said. "I went into programs and turned them around and then moved on."

Twenty years later, Block's legacy at PLNU lives on as the team continues ascending new heights.

"I knew how to recruit and brought in decent players," he said. "We were the cupcake; the guaranteed win on other teams' schedules. I had to turn that around and start scheduling cupcakes to help build a winning culture. We created an environment

of games that were entertaining. I started cheerleading squads and put together things for halftime. I would go to the student body and ask how can we make this thing fun."

Block still lives in Point Loma, but said he doesn't follow much basketball these days.

"There are teams that have movement in the offense, but for the most part it's become a really individual sport," Block said.

In December, Block published a book titled "Building Block" about his career and life.

# Father who drove off Sunset Cliffs with girls to be his own attorney

A father accused of trying to kill his two young daughters by driving them off Sunset Cliffs has officially been allowed to act as his own attorney in his upcoming trial on Sept. 12.

Robert Duane Brians, 50, was repeatedly urged not to become his own attorney considering the legal risks it poses for him, but it was permitted by San Diego Superior Court Judge Michael Groch in a hearing.

In his petition, Brians wrote that he is self-employed and he has completed "some college." He acknowledged that he understands he could be sentenced to life in prison if he is convicted of all charges.

In a handwritten motion from jail this week, Brians asked for a continuance, apparently of the trial date, according to court records. He also asked for the appointment of an advisory counsel in an Aug.

28 hearing.

His twin 3-year-old daughters and himself were nearly killed on June 13, 2020, when he drove off Sunset Cliffs in Point Loma in his truck. They were rescued by San Diego Police officer Jonathan Wiese who climbed down after he saw the truck upside down on a rock around 5 a.m.

Brians has pleaded not guilty to two counts each of the following: attempted murder, child endangerment, child abuse, kidnapping, child abduction, corporal injury, and making a criminal threat.

Brians initialed on court documents that he was aware of the dangers of self-representation and that he waived his right to ineffective assistance of counsel should he be convicted. He also said he understood that the court would not give him any legal help or advice.

He also agreed that he understood the prosecutor would be an

experienced and skilled lawyer and he would be treated just like any other opposing counsel. The prosecutor could not be reached for comment.

Three minutes before the crash, Brians wrote on Facebook that "tonight I'm sending my babies to heaven." The motivation stemmed from a bitter relationship Brians had with the girls' mother.

Both girls were seriously injured and taken to a hospital after being brought up from Sunset Cliffs. The girls had lacerations to internal organs as well as fractures and breathing difficulties, according to testimony from a detective at the preliminary hearing.

Wiese, who used a 100-foot dog leash to lower himself down to the damaged truck, testified he saw Brians holding the two girls in the ocean water. He said he remembered Brians cursing his ex-wife at the scene.

Brians remains in the central jail without bail.

# Drunk driver to stand trial for 2nd-degree murder

A Navy man who previously pleaded guilty to gross vehicular manslaughter while intoxicated in the death of a Point Loma woman has been permitted by a judge to withdraw his guilty plea because of a mistake. However, this means that Eric Deangelo Ramos Cortez, 26, is now once again

charged with second-degree murder as well as manslaughter in the death of Sarah Lombardi, 54, on Interstate 8, on Dec. 20, 2021.

A second-degree murder charge was dismissed when he pleaded guilty, but now with his plea agreement set aside, a trial date was set for Feb. 24, 2024.

A not-guilty plea was reinstated for Ramos before San Diego

Superior Court Judge Rachel Cano and he remains in the George Bailey Detention Facility without bail.

He recently married his 25-year-old girlfriend while in jail, according to court documents. She has attended most of his court hearings.

would say ‘The construction cost has gone up.’ So then they didn’t have anybody (contractor) to do it. Eventually, we came up with a plan to build half the park, and then try to find the money to do the second half. We pushed that, and then, all of a sudden, we had all of the money.”

Kosmo said the planning board made the pocket park a top priority on their list of needs to Campbell’s office, and District 2 “helped pushed for it.”

“I’m grateful to a lot of people who helped,” said Don Sevens, a community activist who shepherded the pocket park throughout its development. “It (project) was kind

of stuck, needed funds to bridge the funding gap, and (COVID and other) delays caused their toll.”

“We’re pleased this (park) is being done,” said Kelly Madruga representing United Portuguese S.E.S. Hall of San Diego. “It’s really nice. It will be great for the kids. The park is at the end of Avenida de Portugal and the (Portuguese) hall is down the street. So, it gives us a great sense of community here.”

“Parks are a wonderful space for families, children, and people of all ages to enjoy the outdoors and be healthy,” said Campbell during the groundbreaking ceremony. “The Cañon Street Pocket Park will enhance the lives of families and children in the Point Loma community, and it will turn a vacant lot into a beautiful area for generations to enjoy.”
